# The Carriage of Goods by Sea (Parties to Convention) Order 1978

Made - - - 20th December 1978

At the Court at Buckingham Palace, the 20th day of December 1978

Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred upon Her by section 2 of the Carriage of Goods by Sea Act 1971(a) and of all other powers enabling Her in that behalf is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

- 1. This Order may be cited as the Carriage of Goods by Sea (Parties to Convention) Order 1978.
- 2. It is hereby certified that the contracting States to the International Convention for the unification of certain rules of law relating to bills of lading signed at Brussels on 25th August 1924, as amended by the Protocol signed at Brussels on 23rd February 1968 and the territories in respect of which they are respectively contracting States are as listed in the Schedule to this Order.
- 3. The Carriage of Goods by Sea (Parties to Convention) Order 1977(b) is hereby revoked.
