The South Africa (Prohibited Exports and Transactions) (Overseas Territories) (Amendment) Order 1978

Made - - - - 20th December 1978

Laid before Parliament 3rd January 1979

Coming into Operation 24th January 1979

At the Court at Buckingham Palace, the 20th day of December 1978 Present.

The Queen's Most Excellent Majesty in Council

Whereas under Article 41 of the Charter of the United Nations the Security Council of the United Nations have, by a resolution adopted on 4th November 1977, called upon Her Majesty's Government in the United Kingdom and all other Members of the United Nations to apply certain measures to give effect to a decision of that Council in relation to the Republic of South Africa:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1 of the United Nations Act 1946(a), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

Citation and commencement

1. This Order may be cited as the South Africa (Prohibited Exports and Transactions) (Overseas Territories) (Amendment) Order 1978 and shall come into operation on 24th January 1979.

Interpretation

2. The Interpretation Act 1889(b) shall apply, with the necessary adaptations, for the purpose of interpreting this Order and otherwise in relation thereto as it applies for the purpose of interpreting and in relation to Acts of Parliament of the United Kingdom, and as if this Order were such an Act of Parliament.

Extent of Order

3. This Order extends to the territories (including the dependencies thereof) mentioned in Schedule 1 to the South Africa (Prohibited Exports and Transactions) (Overseas Territories) Order 1978(c).

Amendment of the South Africa (Prohibited Exports and Transactions) (Overseas Territories) Order 1978

- 4. The South Africa (Prohibited Exports and Transactions) (Overseas Territories) Order 1978 shall be amended by the insertion, at the end of both Article 4(3) and Article 5(3), of the following:—
 - ", and specialised parts and components of any of the apparatus, appliances or equipment falling within a description in that Schedule, whether or not such parts and components are specified in the description.".

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends Articles 4 and 5 of the principal Order by including among the goods to which those Articles apply (and in respect of which export from the overseas territories concerned to South Africa and certain transactions connected with manufacture or maintenance in South Africa are accordingly prohibited) specialised parts and components of the apparatus, appliances and equipment in Schedule 2 to the principal Order.
