## ROAD TRAFFIC

**The Minibus (Designated Bodies) (Amendment) Order 1978***Made - - - - 20th December 1978**Laid before Parliament 5th January 1979**Coming into Operation 26th January 1979*

The Secretary of State for Transport, in exercise of his powers under section 1(3) of the Minibus Act 1977(a) and of all other enabling powers, hereby makes the following Order:—

1. This Order shall come into operation on 26th January 1979, and may be cited as the Minibus (Designated Bodies) (Amendment) Order 1978.

2. The Minibus (Designated Bodies) Order 1977(b) shall be amended so as to have effect in accordance with the following provisions of this Order.

3. In the Schedule—

(a) in column (2) for the words “the Education (Scotland) Act 1962, as amended” in both places where they appear, there shall be substituted the words “the Education (Scotland) Act 1962(c) as amended by the Education (Scotland) Act 1969(d) and the Education (Scotland) Act 1976(e)”;

(b) after the seventh item in column (1) and the related items in column (2) the following additional items shall be inserted in columns (1) and (2):—

(c) for the eighth item in column (1) (which specifies the Council of the Orkney, Shetland and the Western Isles islands areas, respectively) and the related items in column (2) there shall be substituted the following:—

The councils of the Orkney, Shetland and Western Isles islands area, respectively.	(a) Bodies connected with the fulfilment of any duty imposed on the designated body by the Social Work (Scotland) Act 1968(a); (b) Schools or other educational establishments which fulfil the duty of the designated body under the Education (Scotland) Act 1962 as amended by the Education (Scotland) Act 1969 and the Education (Scotland) Act 1976, with respect to the provision of education, and bodies connected with such schools or educational establishments. (c) Community councils within the area of the designated body.”;

(d) at the end the following additional items shall be inserted in columns (1) and (2):—

The Church of Scotland.	Bodies comprised in the designated body.
The Association of Strict Baptist Churches Limited.	Bodies comprised in the designated body or with a purpose or purposes similar to those of the designated body.

The British Trust for Conservation Volunteers Limited.	The National Conservation Corps or any unit thereof, and any bodies which are comprised in or affiliated to the designated body.
The Campaigners.	Bodies comprised in the designated body or with a purpose or purposes similar to those of the designated body.

The Girl Crusaders' Union.	Bodies comprised in the designated body.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

The Minibus (Designated Bodies) Order 1977 designated bodies who (in addition to the Traffic Commissioners) under the Minibus Act 1977 may grant permits, either to themselves or to the class of bodies specified in the Order, for the use of certain minibuses. This Order amends the 1977 Order by designating further bodies and classes of bodies.
