# Act of Sederunt (Rules of Court Amendment No. 7) (Solicitors' Fees) 1978

Made - - -

5th July 1978

Coming into Operation

1st October 1978

The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 16 of the Administration of Justice (Scotland) Act 1933(a), and of all other powers competent to them in that behalf, do hereby enact and declare:

Citation, commencement amd interpretation

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Rules of Court Amendment No. 7) (Solicitors' Fees) 1978 and shall come into operation on 1st October 1978.
- (2) The Interpretation Act 1889(b) shall apply to the interpretation of this Act of Sederunt as it applies to the interpretation of an Act of Parliament.
  - (3) This Act of Sederunt shall be inserted in the Books of Sederunt.

New fees

2. In Rule 347 of the Rules of Court (c), for the tables of fees set out in Chapters I, III (other than Parts VI and VII) and V, there are substituted the tables of fees set out under these Chapters in the Schedule to this Act of Sederunt, and the fees so substituted shall have effect on and after 1st October 1978 and are the fees chargeable by solicitors in respect of the matters specified in the Schedule opposite these fees, being matters relating to work done or expenses incurred on and after that date.

#### Revocation

- 3. The Act of Sederunt (Rules of Court Amendment No. 8) (Solicitors' Fees No. 2) 1976(d) is revoked.
  - 4. In the said rule 347, paragraph (i) is revoked.

	CHAPTER V	

Undefended Consistorial Actions under Legal Aid (Scotland) Act 1967

In undefended consistorial actions in which the pursuer, having a finding for expenses, has been throughout the whole of the proceedings an Assisted Person under the Legal Aid (Scotland) Act, 1967, the pursuer's solicitor may in his option either:—

elect to charge an inclusive charge to cover all work from taking instructions up to and including obtaining extract decree with in addition a charge for outlays as hereinafter provided. Provided that such inclusive charge shall be—

- (i) where only an Edinburgh solicitor is engaged in the case ... £144.00
- or (ii) where the Legal Aid Certificate shows that both an Edinburgh solicitor and a solicitor outside Edinburgh are engaged in the case or where an official on behalf of the Legal Aid Supreme Court Committee of the Law Society so certifies ... £200.00

In addition to the said inclusive charge a sum of up to £65 shall be allowed as outlays where a Certificate by the Auditor of Court is lodged certifying the outlays which have been incurred, and the Court shall grant decree accordingly, and if outlays in excess of £65 are claimed an account for the said outlays shall be remitted to the Auditor for taxation.

This option shall be exercised by the pursuer's solicitor enrolling a motion for decree for either the appropriate inclusive charge and for a sum for outlays as shown in the said Certificate not exceeding £65 or a motion for the appropriate inclusive charge and an order remitting the account of outlays to the Auditor of Court for taxation.

### **EXPLANATORY NOTE**

(This Note is not part of the Act of Sederunt)

This Act of Sederunt amends the Rules of Court to make new provision in respect of solicitors' fees for the Court of Session business detailed in Chapters I and III of Rule 347 and re-enacts the existing fees in Chapter V of that Rule.
