The Increase of Pensions (India, Pakistan and Burma) (Amendment) Regulations 1979

Made - - - 9th October 1979

Laid before Parliament 18th October 1979

Coming into Operation 12th November 1979

In exercise of the powers conferred on me by sections 5(3), 10 and 11A of the Pensions (Increase) Act 1971(a) and section 7(2) of and Part I of Schedule 2 to the Ministers of the Crown Act 1975(b) and with the approval of the Minister for the Civil Service, I hereby make the following Regulations:—

Citation, construction and commencement

- 1.—(1) These Regulations may be cited as the Increase of Pensions (India, Pakistan and Burma) (Amendment) Regulations 1979 and shall be construed as one with the Increase of Pensions (India, Pakistan and Burma) Regulations 1972(c) (hereinafter referred to as the "principal Regulations").
 - (2) These Regulations shall come into operation on 12th November 1979.

Amendment of regulation 11 of the principal Regulations

- 2. Regulation 11 of the principal Regulations is amended:—
 - (a) in paragraph (2), by deleting the words "section 2 of the Act" and substituting the words "section 59 of the Social Security Pensions Act 1975(d)";
 - (b) in paragraph (5) sub-paragraph (ii), by deleting the words "section 2 of the Act" and substituting the words "section 59 of the Social Security Pensions Act 1975", and deleting the words "review period" and substituting the words "base period";
 - (c) in paragraph (5), by inserting at the end the following definition:—
 - ""base period" means the period ending with the coming into force of the direction issued by virtue of section 23 of the Social Security Pensions Act 1975 and beginning with the coming into force of the last previous such direction."

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Increase of Pensions (India, Pakistan and Burma) Regulations 1972 so as to provide for increases payable in respect of the pensions specified in Schedules 1 and 2 to those Regulations, to be calculated by reference to increases payable on a Civil Service pension under the provisions of section 59 of the Social Security Pensions Act 1975, following the coming into operation of those provisions.
