REGISTRATION OF BIRTHS, DEATHS, MARRIAGES, ETC.

The Registration of Births, Deaths and Marriages (Fees) (Scotland) Regulations 1979

Made - - - 8th February 1979
Laid before Parliament 22nd February 1979
Coming into Operation 1st April 1979

In exercise of the powers conferred upon me by section 54(1)(a) and (b) of the Registration of Births, Deaths and Marriages (Scotland) Act 1965(a), and with the approval of the Secretary of State, I hereby make the following regulations:—

Citation and commencement

1. These regulations may be cited as the Registration of Births, Deaths and Marriages (Fees) (Scotland) Regulations 1979 and shall come into operation on 1st April 1979.

Interpretation

- 2. In these regulations:—
- "general search" means a search, over any period of years for any number of entries, made by any person with the permission of the Registrar General or the registrar;
- "particular search" means a search for a specified entry caused to be made by the Registrar General or made by a registrar.

Fees

- 3.—(1) Subject to the following provisions of this regulation, the fees payable under the provisions specified in column 1 of Schedules 1 and 2 to these regulations in respect of the services described in column 2 of those Schedules shall be respectively the amounts specified in column 3 thereof.
- (2) The Registrar General may authorise the remission of a fee or part of a fee in any case where (a) the payment of the fee is likely to cause hardship to the person by whom it is payable or (b) the service in respect of which the fee is payable is performed for research purposes.
- (3) The Registrar General may, on application by any body or organisation not operating for profit, determine an annual inclusive fee for general searches made by such body or organisation in lieu of the fees for general searches as set out in Schedule 1 to these regulations, and any fee so determined shall not exceed the fees otherwise payable under the said Schedule, and shall be subject to annual review thereafter.

4. The Registration of Births, Deaths and Marriages (Fees) (Scotland) Regulations 1977(a) are hereby revoked.
