# The Lyon Court and Office Fees (Variation) Order 1979

Made -9th November 1979

Laid before Parliament 26th November 1979

Coming into Operation 17th December 1979

In exercise of the powers conferred on me by section 5 of, as read with paragraph 3 of Schedule 3 to, the Public Expenditure and Receipts Act 1968(a), and of all other powers enabling me in that behalf, I hereby make the following order:—

- 1. This order may be cited as the Lyon Court and Office Fees (Variation) Order 1979 and shall come into operation on 17th December 1979.
- 2. The fees in Schedule B to the Lyon King of Arms Act 1867(b) in respect of the matters specified in the first column of the Schedule to this order shall be amended by substituting for the sums specified in the second column of that Schedule the sums specified in the third column of the Schedule to this order.
