## **CUSTOMS AND EXCISE**

# The Customs Duties (ECSC) (Quota and Other Reliefs) (Amendment) Order 1979

Made -16th February 1979

Laid before the House

of Commons -16th February 1979

Coming into Operation 19th February 1979

The Secretary of State, in exercise of the powers conferred on him by sections 5 and 13 of, and paragraph 8(2) of Schedule 3 to, the Import Duties Act 1958(a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

- 1. This Order may be cited as the Customs Duties (ECSC) (Quota and Other Reliefs) (Amendment) Order 1979 and shall come into operation on 19th February 1979.
- 2. The Customs Duties (ECSC) (Quota and Other Reliefs) Order 1978(b) shall be amended as follows:-
  - (a) in Article 2(c) for the words "23rd December 1977" there shall be substituted "23rd January 1979"(c)
  - (b) after Article 3 there shall be inserted the following Article:
    - "3A. After relief ceases to be available under the relevant quota, up to and including 31st December 1979 no customs duty shall be charged on goods referred to in Article 3(1) which originate in a country named in both Schedules 2 and 3 hereto."
  - (c) for Part II of Schedule 1 there shall be substituted the following:

#### **EXPLANATORY NOTE**

(This Note is not part of the Order.)

This Order amends the Customs Duties (ECSC) (Quota and Other Reliefs) Order 1978 by increasing the amounts of the duty-free tariff quotas and the maximum amounts within the quotas listed in columns 2 and 3 respectively of Part II of Schedule 1 in accordance with a Decision of the representatives of the governments of the member States of the European Coal and Steel Community meeting in Council dated 29th December 1978 (O.J. No. L375, 30.12.78 p. 163). The amounts are greater than those provided for in the 1978 Order which opened the quotas for 1979 and in the Order opening the corresponding quotas for 1978 (S.I. 1977/2143) by about 3 per cent. This represents an overall increase of £119,623 in the amount of the quotas, whilst the maximum amounts within the quotas are increased by an overall total of £43,415.

The Order provides for the exemption from duty for goods listed in Part II of Schedule 1 originating in the least developed developing countries listed in Schedule 3 to continue after the tariff quotas have been used up, up to and including 31st December 1979. The Order also substitutes for the EEC Regulations relating to origin referred to in the 1978 Order a reference to the most recent origin Regulations and makes additions to the countries listed in Part I of Schedule 2.
