# INDUSTRIAL AND PROVIDENT SOCIETIES

# The Industrial and Provident Societies (Amendment of Fees) Regulations 1979

Made - - - - 26th November 1979

Laid before Parliament 10th December 1979

Coming into Operation 1st January 1980

The Treasury, in exercise of the powers conferred upon them by section 70(1) of the Industrial and Provident Societies Act 1965(a), and by that section as applied by section 7(2) of the Industrial and Provident Societies Act 1967(b), and of all other powers enabling them in that behalf, hereby make the following Regulations:—

- 1. These Regulations may be cited as the Industrial and Provident Societies (Amendment of Fees) Regulations 1979 and shall come into operation on 1st January 1980.
- 2. The Industrial and Provident Societies Regulations 1965(c) shall be amended by substituting for Schedule 2 thereto the following Schedule:—

For a copy or extract of any document on a file kept as aforesaid not exceeding 216 words, £2 and, if exceeding that number, 46p per folio of 72 words, in addition to the fee, if any, for the signature of a Registrar or seal of the Central Office: provided that where a photocopy is supplied the fee charged therefor may be for an amount less than the fee payable on the basis of word content.

For a document certified as a true copy of a document on a file kept as afore-said, where the copy so certified is not made by the Registrar, 90p for the examination of such copy, and, if the copy exceeds 216 words, for every additional folio of 72 words, 18p (in addition to the fee for the signature of a Registrar, or seal of the Central Office): provided that the fee to be charged for the examination and authentication of copies of rules or amendments of rules required for the purposes of recording shall not be greater than the fee paid for acknowledgment of registration of the society or of the amendment of rules as the case may be.

The fee for the acknowledgment of registration of a society the rules of which are in the form of model rules, where the application for the registration is made through and endorsed by the association or body which has sponsored the rules contained in the said model, shall be £59.

The fee for the acknowledgment of registration of an amendment of rules being a substitution of an entire set of rules for the existing set of rules, where the entire set of rules are in the form of model rules and where the application for registration is made through and endorsed by the association or body which has sponsored the rules contained in the said model, shall be £42.

The fee for an award on a dispute may be reduced or waived as the Registrar to whom the dispute is referred may think fit."

- 3. The Industrial and Provident Societies Regulations 1967(a) are hereby amended by the substitution of "£3" for "£2.15" in regulation 5.
- 4. The Industrial and Provident Societies (Amendment of Fees) Regulations 1978(b) are hereby revoked.

# **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

These Regulations increase the fees to be paid for matters to be transacted and for the inspection of documents under the Industrial and Provident Societies Acts 1965 and 1967. They supersede the Industrial and Provident Societies (Amendment of Fees) Regulations 1978 and amend the Industrial and Provident Societies Regulations 1965 and 1967.
