CUSTOMS AND EXCISE

**The Export of Goods (Control) (Amendment No. 2)
Order 1979**

Made - - - - - 19th February 1979

Coming into Operation 19th March 1979

The Secretary of State, in exercise of the powers conferred by section 1 of the Import, Export and Customs Powers (Defence) Act 1939(a) and now vested in him(b), and of all other powers enabling him in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Export of Goods (Control) (Amendment No. 2) Order 1979 and shall come into operation on 19th March 1979.

2. The Export of Goods (Control) Order 1978(c) shall be amended as follows:—

For Group B of Part I of Schedule 1 there shall be substituted the following:

- “
- GROUP B**
- PHOTOGRAPHIC MATERIAL, ANTIQUES, COLLECTORS' ITEMS, ETC.
- Any photographic positive or negative produced more than 60 years before the date of exportation, the value of which, as required by the Commissioners of Customs and Excise to be declared, is £200 or more A
- except any photographic positive or negative exported by, and being the personal property of, the manufacturer or producer thereof, or the spouse, widow or widower of that person.
- Any goods manufactured or produced more than 50 years before the date of exportation A
- except
- (i) photographic positives and negatives;
 - (ii) postage stamps and other articles of philatelic interest;
 - (iii) birth, marriage or death certificates or other documents relating to the personal affairs of the exporter or the spouse of the exporter;
 - (iv) letters or other writings written by or to the exporter or the spouse of the exporter;
 - (v) any goods exported by, and being the personal property of, the manufacturer or producer thereof, or the spouse, widow or widower of that person.”

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order further amends the Export of Goods (Control) Order 1978 by substituting a new form of control on antiques and other collectors' items. Subject to certain exceptions this Order brings into control the export of all goods, other than photographic positives and negatives, manufactured or produced more than 50 years before the date of exportation. Photographic positives and negatives are now controlled if produced more than 60 years before the date of exportation. The main changes are that the age-limit below which goods can be exported is reduced and that an additional exception to control is added, namely, for goods exported by, and being the personal property of, the manufacturer or producer thereof, or the spouse, widow or widower of that person.
