## ROAD TRAFFIC

The Secretary of State's Traffic Orders (Procedure) (Scotland)  
Amendment Regulations 1979

<i>Made</i> - - - -	26th February 1979
<i>Laid before Parliament</i>	9th March 1979
<i>Coming into Operation</i>	30th March 1979

In exercise of the powers conferred on me by section 84C of the Road Traffic Regulation Act 1967(a) and as read with section 32 of the Countryside Act 1968(b), and of all other powers enabling me in that behalf, and after consultation with representative organisations in accordance with section 107(2) of the said Act of 1967, I hereby make the following regulations:—

*Citation and commencement*

1. These regulations may be cited as the Secretary of State's Traffic Orders (Procedure) (Scotland) Amendment Regulations 1979, and shall come into operation on 30th March 1979.

*Amendment*

2. The Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1973(c) shall be amended as follows:

- (a) in regulation 2 (*Interpretation*), in paragraph (3), after the words "an order under any particular section of the Act" there shall be added the words "or under section 36B(5) of the Road Traffic Act 1972";
- (b) in regulation 2, after paragraph (3), there shall be added, the following paragraph—
  - "(3A) In relation to an order under section 36B(5) of the Road Traffic Act 1972 any reference in these regulations to section 84A, 84C or 84D of the Act shall be construed as a reference to that section as applied by section 36B(7) of the said Act of 1972";
- (c) in regulation 3 (*Application of regulations*), in paragraph (1)(b), after the words "sections 1(1) to (7), 9, 73 and 74" there shall be added the words "or under section 36B(5) of the Road Traffic Act 1972";
- (d) In Schedule 1 (*Particulars to be included in press notices*), in paragraph 7 of Part IV, after the words "under section 1, 5, 9, 15, 28, 33

or 35 of the Act” there shall be added the words “or under section 36B(5) of the Road Traffic Act 1972”, and after the words “of the relevant section of the Act” there shall be added the words “or of section 36B of the Road Traffic Act 1972 (as the case may be)”.

#### EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These Regulations apply the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1973 to Orders under section 36B of the Road Traffic Act 1972 (a section added to that Act by section 7 of the Road Traffic Act 1974) these being Orders for exempting roads from the prohibition of the parking of vehicles on verges, central reservations and footways imposed by the section.
