Coming into Operation *28th March 1979*

In exercise of the powers conferred upon me by paragraph 4(1) of Schedule 1 to the European Assembly Elections Act 1978(a), I hereby make the following Order:—

1. This Order may be cited as the European Assembly Elections (Returning Officers) (England and Wales) Order 1979 and shall come into operation twenty-eight days after the day on which it is made.

2. In England and Wales the returning officer for an European Assembly election in the European Assembly constituency specified in column 1 of the Schedule to this Order shall be the returning officer for parliamentary elections for the parliamentary constituency specified opposite thereto in column 2 of the said Schedule.
