The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 2 of the Courts of Law Fees (Scotland) Act 1895(a) and of section 40 of the Sheriff Courts (Scotland) Act 1907(b) as amended by section 39 of the Administration of Justice (Scotland) Act 1933(c) and of all other powers enabling them in that behalf, and with the concurrence of the Treasury, do hereby enact and declare:—

Citation and commencement

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Amendment of Fees for Sheriff Clerks) 1979 and shall come into operation on 1st May 1979.
 - (2) This Act of Sederunt shall be inserted in the Books of Sederunt.

Amendments to Act of Sederunt (Fees for Sheriff Clerks) 1977

2. In the Act of Sederunt (Fees for Sheriff Clerks) 1977(d), as amended by the Act of Sederunt (Amendment of Fees for Sheriff Clerks) 1978(e), for Parts II and III of the Schedule substitute Parts II and III of the Schedule to this Act of Sederunt, and the fees specified in those Parts shall be payable from the date this Act of Sederunt comes into operation.

Revocation

3. Chapter XI of the Schedule to the Act of Sederunt spent fees of solicitors and others in the Sheriff Court (Auditor's Fees)(f), as amended(g), is revoked.
