MEDICINES

The Medicines (Prescription Only) Amendment Order 1979

Made - - - 12th January 1979
Laid before Parliament 19th January 1979
Coming into Operation 10th February 1979

The Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, in exercise of powers conferred by sections 58(1) and (4)(a) and 129(4) of the Medicines Act 1968(a) and now vested in them(b) and of all other powers enabling them in that behalf, after consulting such organisations as appear to them to be representative of interests likely to be substantially affected by the following order, and after consulting and taking into account the advice of the Medicines Commission, hereby make the following order:—

- 1. This order may be cited as the Medicines (Prescription Only) Amendment Order 1979 and shall come into operation on 10th February 1979.
- 2. In Article 11B(1) of the Medicines (Prescription Only) Order 1977(c), for "11th February 1979" there is substituted "11th February 1980".

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order amends the Medicines (Prescription Only) Order 1977 (as amended by the Medicines (Prescription Only) Amendment (No. 2) Order 1978) by postponing from 11th February 1979 to 11th February 1980 the termination of a temporary exemption from the restriction imposed by section 58(2)(b) of the Medicines Act 1968 (restriction on the administration of prescription only medicines). The exemption relates to the administration of certain injectable medicinal products to humans by certain persons in the course of a business where the person administering the product in question could have done so lawfully before 11th August 1978 otherwise than in accordance with a prescription.
