SEEDS

The Seed Potatoes (Fees) Regulations 1979

Made - - - - 26th March 1979

Laid before Parliament 3rd April 1979

Coming into Operation 24th April 1979

The Minister of Agriculture, Fisheries and Food in relation to England and the Secretary of State for Wales in relation to Wales, in exercise of the powers conferred by sections 16(1), (1A)(e), (5)(a) and (8) of the Plant Varieties and Seeds Act 1964(a), as amended by section 4(1) of and paragraph 5(1), (2) and (3) of Schedule 4 to the European Communities Act 1972(b) and now vested in them(c), and of all, other powers enabling them in that behalf, after consultation with representatives of such interests as appear to them to be concerned, hereby make the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Seed Potatoes (Fees) Regulations 1979 and shall come into operation on 24th April 1979.

Revocation of previous regulations

2. The Seed Potatoes (Fees) Regulations 1978(d) are hereby revoked.

Fees

3. There shall be paid in advance in respect of matters arising under the Seed Potatoes Regulations 1978(e) referred to in the Schedule hereto or under any regulations amending or superseding them the fees respectively specified in the second column of the said Schedule opposite the references to such matters.

4. The said fees shall be payable to the Minister of Agriculture, Fisheries and Food (hereinafter referred to as "The Minister").

5. The Minister may exempt any person or class of persons or persons generally from compliance in whole or in part with the provisions of these Regulations in relation to payment of fees and any exemptions so made may be made subject to conditions.

A. Basic Seed Potatoes	
(a) VTSC grade per half-hectare or part thereof	23·70
(b) FS grade per half-hectare or part thereof	20·80
Minimum fee	40·90
(c) SS grade per half-hectare or part thereof	19·90
Minimum fee	39·80
(d) AA grade per half-hectare or part thereof	12·90
Minimum fee	25·70
B. Certified Seed Potatoes per half-hectare or part thereof	12·90
Minimum fee	25·70
Provided that if an application for entry of crops to produce A. or B. is withdrawn before the arrival of an inspector for the purpose of inspecting the crop for the first time the fee paid will be repaid to the applicant.

These Regulations are made under the Plant Varieties and Seeds Act 1964 as amended by the European Communities Act 1972.
