PENSIONS

The Local Government Superannuation (Amendment) (No. 2) Regulations 1979

Made - - - 24th May 1979
Laid before Parliament 5th June 1979
Coming into Operation 2nd July 1979

The Secretary of State for the Environment, in exercise of the powers conferred upon him by sections 7 and 12 of the Superannuation Act 1972(a), and of all other powers enabling him in that behalf, after consultation with such associations of local authorities as appeared to him to be concerned, the local authorities with whom consultation appeared to him to be desirable and such representatives of other persons likely to be affected by the regulations as appeared to him to be appropriate, hereby makes the following regulations:—

Citation and commencement

- 1.—(1) These regulations may be cited as the Local Government Superannuation (Amendment) (No. 2) Regulations 1979.
- (2) The Local Government Superannuation Regulations 1974 to 1979(b) and these regulations may be cited together as the Local Government Superannuation Regulations 1974 to 1979.
- (3) These regulations shall come into operation on 2nd July 1979 and shall have effect as from 1st May 1979.

Interpretation

2. In these regulations "the principal regulations" means the Local Government Superannuation Regulations 1974(c).

Treatment of certain additional duties

- 3. Regulation A7 of the principal regulations is amended—
 - (a) by inserting at the beginning the figure "(1)"; and
 - (b) by adding at the end the following:
 - "(2) For the purposes of paragraph (1), the duty of an acting returning officer includes any duties of a returning officer at an Assembly election which are required by regulations made under paragraph 2 of Schedule 1 to the European Assembly Elections Act 1978(d) to be discharged by an acting returning officer.".

Reckonable service

- **4.** Regulation D1(1)(c) of the principal regulations is amended—
 - (a) by substituting for the words "regulations A7(a) and B2(1)(c)" the words "regulations A7(1)(a) and B2(1)(c)", and
 - (b) by substituting for the words "regulation A7(a)" the words "regulation A7(1)(a)".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend regulation A7 of the Local Government Superannuation Regulations 1974 (treatment of certain additional duties of whole-time officers as separate variable-time employment) so that for the purposes of that regulation the duty of an acting returning officer includes duties required to be discharged by such an officer at a European Assembly election.
