ROAD TRAFFIC

**The Removal and Disposal of Vehicles (Amendment)
Regulations 1980**

<i>Made</i> - - - - -	8th February 1980
<i>Laid before Parliament</i>	19th February 1980
<i>Coming into Operation</i>	11th March 1980

The Minister of Transport (as respects England), the Secretary of State for Scotland (as respects Scotland) and the Secretary of State for Wales (as respects Wales), in exercise of the powers conferred by sections 4(5) and 5(1) of the Refuse Disposal (Amenity) Act 1978(a) and section 52(1) and 53(3) of the Road Traffic Regulation Act 1967(b), and now vested in them(c), and of all other enabling powers, and after consultation with representative organisations in accordance with the provisions of section 107(2) of the Road Traffic Regulation Act 1967, hereby make the following Regulations:—

1. These Regulations may be cited as the Removal and Disposal of Vehicles (Amendment) Regulations 1980 and shall come into operation on 11th March 1980.

2. The Removal and Disposal of Vehicles Regulations 1968(d) shall be further amended so that in Regulation 17(1) (Charge for removing vehicles):—

in sub-paragraph (a) (removals from motorways) for “£24” there shall be substituted “£30”;

in sub-paragraph (b)(i) (other removals in London) for “£22” there shall be substituted “£29”;

in sub-paragraph (b)(ii) (other removals elsewhere than in London) for “£20” there shall be substituted “£27”.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

1. These Regulations increase the charges payable under the Removal and Disposal of Vehicles Regulations 1968 (as amended).
2. The charge for removing a vehicle from a motorway is increased from £24 to £30. The charge for removing a vehicle from a place not on a motorway is increased from £22 to £29 for removals in London and from £20 to £27 for removals elsewhere.
