**The Registration of Births, Deaths and Marriages (Fees)
(Scotland) Order 1980**

In exercise of the powers conferred on me by section 5 of and Schedule 3 to the Public Expenditure and Receipts Act 1968(a) and of all other powers enabling me in that behalf, I hereby make the following order:—

Citation and commencement

1. This order may be cited as the Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1980 and shall come into operation on 1st April 1980.

Fees

2. The fees payable under the enactments specified in column 2 of the Schedule to this order in respect of the certificates described in column 3 of that Schedule shall be the amounts respectively specified in column 4 thereof.

Revocation

3. The Registration of Births, Deaths and Marriages (Fees) (Scotland) Order 1977(b) is hereby revoked.
