EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order brings into force on 1st October 1981 the provisions of the Broadcasting Act 1980 specified in Schedule 1 to this Order, namely section 26 and Schedule 4 (which relate to rental payments by local sound programme contractors), section 27 (which relates to grants by the Independent Broadcasting Authority to local sound programme contractors), section 40(5) (the repeal of the Independent Broadcasting Authority Act 1979), section 40(4) together with Schedule 6 for the purposes of certain transitional provisions and section 40(6) together with Schedule 7 for the purposes of certain repeals.

The Order also brings into force on 1st January 1982 the provisions of the Act specified in Schedule 2 to the Order, namely section 35 (which relates to the training of persons employed by programme contractors) and section 40(4) together with Schedule 6 for the purposes of certain transitional provisions.

On 1st January 1982 the whole of the Broadcasting Act 1980 will have been brought into force.
