Whereas in pursuance of section 2 of the Professions Supplementary to Medicine Act 1960(a) the Council for Professions Supplementary to Medicine has made the Registration (Amendment No. 2) Rules 1980:

And whereas by subsection (3) of the said section such rules shall not come into force until confirmed by Order of the Privy Council:

Now, therefore, Their Lordships, having taken the said rules into consideration, are hereby pleased to confirm the same as set out in the Schedule to this Order.

This Order may be cited as the Professions Supplementary to Medicine (Registration Rules) (Amendment) Order of Council 1981.

SCHEDULE

THE REGISTRATION (AMENDMENT NO. 2) RULES 1980

The Council for Professions Supplementary to Medicine, in exercise of its powers under section 2 of the Professions Supplementary to Medicine Act 1960, hereby makes the following rules:—

- 1. These rules may be cited as the Registration (Amendment No. 2) Rules 1980.
- 2. The Registration Rules 1962 (scheduled to the Professions Supplementary to Medicine (Registration Rules) Order of Council 1962(a) shall be further amended as follows:—
 - (i) Rule 15 shall be deleted and the following rule shall be substituted therefor: "15. The registration fee shall be paid at the time of the application for registration. As from 1st June, 1981 the fee shall be £11 but shall be reduced to £5.50 in the case of a person whose registration fee entitles him to retain his name on the register for less than 26 weeks."
 - (ii) Rule 19(iv) shall be deleted and the following rule shall be substituted therefor: "(iv) As from 1st June, 1981 the retention fee in respect of a year or any part of a year shall be £7.30."
 - (iii) Rule 20(b) shall be deleted and the following rule shall be substituted therefor: "(b) In all other cases the fee shall be £1.70."
