The Macclesfield (Parishes) Order 1981

Made - - - - 26th February 1981

Coming into Operation -

for the purposes described in article 2

4th March 1981

for all other purposes -

1st April 1981

Whereas the Borough Council of Macclesfield, under section 48(8) of the Local Government Act 1972(a), made recommendations to the Local Government Boundary Commission for England for proposals in relation to parishes in the borough;

And whereas the said Commission, under sections 47 and 51(1) of the said Act, made such proposals to the Secretary of State for the Environment:

Now therefore the Secretary of State for the Environment, in exercise of his powers under sections 51(2) and 67(4) of the said Act and of all other powers enabling him in that behalf, hereby makes the following order:—

Title and commencement

1. This order may be cited as the Macclesfield (Parishes) Order 1981.

2. 4th March 1981 is hereby specified as the day on which this order shall come into operation for any purposes set out in regulation 4(1) (Coming into operation of order) of the Regulations.

For all other purposes this order shall come into operation on the appointed day.

Interpretation

3. In this order—

“the appointed day” means 1st April 1981;

“the county” means the County of Cheshire;

“the borough” means the Borough of Macclesfield, and “the borough council” means the council of the borough;

“the new parish” means the Parish of Macclesfield Forest and Wildboarclough constituted by this order; and

“the Regulations” means the Local Government Area Changes Regulations 1976(a) as amended by the Local Government Area Changes (Amendment) Regulations 1978(b).

The boundary maps

4. In this order—

“the boundary maps” means the 3 maps printed for Her Majesty’s Stationery Office by Ordnance Survey, each such map being marked “Map referred to in the Macclesfield (Parishes) Order 1981” and with the number of the map; and

any reference to a numbered boundary map is a reference to the map described and numbered as aforesaid.

Changes in areas

5.—(1) The Parishes of Macclesfield Forest and Wildboarclough shall be amalgamated to constitute a new parish to be known as the Parish of Macclesfield Forest and Wildboarclough.

The new parish shall form or remain part of the Macclesfield Forest electoral division of the county, of the Sutton ward of the borough, of the Macclesfield petty sessional division and of the East Cheshire coroner’s district.

(2) The parts of parishes described in column (1) of the Schedule to this order and marked on the boundary maps as specified in column (2) shall, in so far as parishes, wards thereof, electoral divisions of the county and wards of the borough are specified in respect thereof in columns (3) to (6), be transferred to or form part of such areas.

(3) The part of the Parish of Chorley which is marked B on boundary map 1 shall cease to form part of the parish and shall form part of the Wilmslow Bollin electoral division of the county and of the Fulshaw ward of the borough.

(4) The parts of the area of the former urban district of Wilmslow which are marked C1 and C2 on boundary maps 1 and 2 shall form part of the Parish of Alderley Edge, of the Alderley electoral division of the county and of the Alderley Edge ward of the borough.

(5) In relation to electoral divisions of the county, this article shall have effect in relation to elections to be held on or after 7th May 1981.

Dissolution of parish authorities

6. The Parish Meetings and Parish Trustees of Macclesfield Forest and Wildboarclough shall be dissolved. For the purposes of any provision of the Regulations which refers to the residuary successor of a dissolved authority the parish meeting and parish trustees of the new parish are hereby specified as the residuary successors of such parish meetings and parish trustees respectively.

Parish meeting

7. The first assembly of the parish meeting of the new parish shall be convened by the person appointed for that purpose by the borough council.

Local Acts, orders and byelaws

8.—(1) The area of the former urban district of Wilmslow shall be a relevant area within the meaning of regulation 41 (Local Acts, orders and byelaws) of

the Regulations and is hereby specified in relation to paragraph (4) of that regulation, and the area comprising—

the first mentioned area other than the parts thereof to which article 5(4) applies, and

the area to which article 5(3) applies,

is hereby specified in relation to the first mentioned area,

(2) The provision of paragraph (1) is without prejudice to the operation of regulation 41(3) of the Regulations in respect of any parish as altered.

(3) The Parishes of Macclesfield Forest and Wildboarclough are hereby specified in relation to the said regulation 41(4) and the new parish is hereby specified in relation to such parishes.

Property, liabilities, contracts, etc., notices and proceedings

9. In relation to the area marked A3 on boundary map 1, the Regulations shall have effect as if the expression “parish authority for a parish” in the Table to Schedule 6 thereof included the Ollerton and Marthall Parish Council.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order—

- (a) amalgamates the Parishes of Macclesfield Forest and Wildboarclough, in the Borough of Macclesfield, to constitute the Parish of Macclesfield Forest and Wildboarclough;
- (b) effects the transfer of parts of parishes, in the borough, to other parishes;
- (c) effects some adjustments between parishes and a part of the borough which is not comprised in any parish,

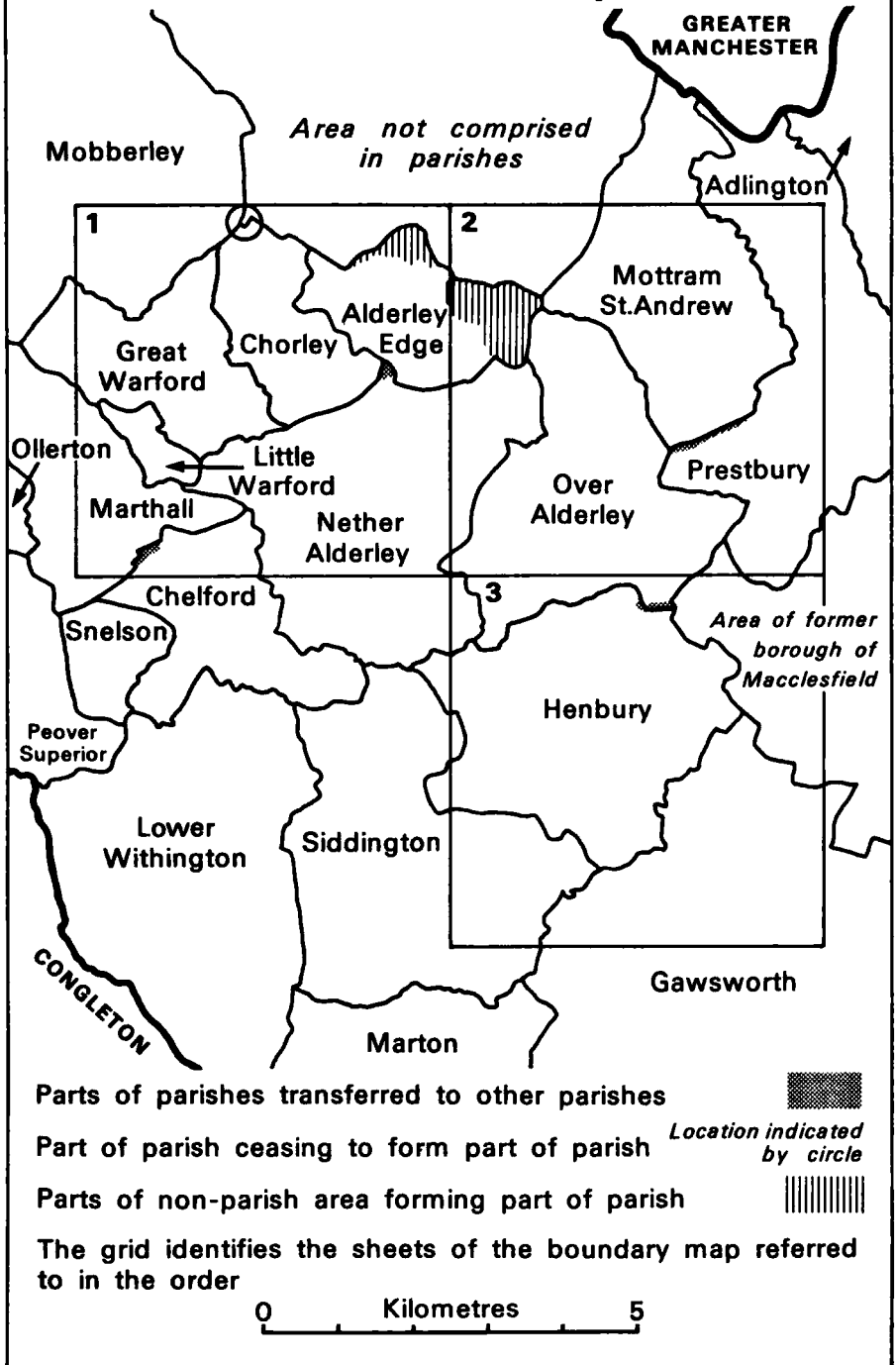
The map forming part of this note (page 6) shows the areas covered by (b) and (c) as from 1st April 1981. This map also incorporates a grid identifying the maps referred to in article 4 of the order.

The new parish will have approximately an area of 3550 hectares, a population of 230 and a rateable value of £15,043.

Prints of the map referred to in article 4 of the order may be inspected at the offices of the borough council. Prints may be purchased from the Department of the Environment's Map Library.

Incidental, consequential, transitional and supplementary provision in consequence of orders of the nature of the present one is contained in the Regulations referred to in article 3 of the order.
