The Health Services Act 1980 (Consequential Amendments) Order 1982

The Secretary of State for Social Services, as respects England, and the Secretary of State for Wales, as respects Wales, in exercise of powers conferred by section 1(8) of the Health Services Act 1980(a), and of all other powers enabling them in that behalf, hereby make the following order:—

Citation and commencement

1. This Order may be cited as the Health Services Act 1980 (Consequential Amendments) Order 1982 and shall come into operation on 1st April 1982.

Amendment to instruments

2. The modification of instruments set out in Schedule 1 hereto shall have effect.

Transitional modifications

3. The modifications of enactments and instruments for which provision is made in Schedule 2 hereto shall have effect.

The Mental Health Review Tribunal Rules 1960

SCHEDULE 2

Article 3

TRANSITIONAL MODIFICATIONS OF ENACTMENTS AND INSTRUMENTS

1. For the purpose of securing continuity in the arrangements made for the provision of services under Part II of the National Health Service Act 1977(a), and in the administration of those arrangements, the following provisions shall apply where a Family Practitioner Committee (referred to in the following paragraphs as a "new Committee") is established or adopted by a District Health Authority or by more than one such Authority pursuant to the provisions of section 10 of that Act or section 2(1) or (2) of the Health Services Act 1980(b); and the enactments and instruments specified in the Table below shall have effect and be construed accordingly.

The National Health Service Act 1977, Part II.

The Health Services Act 1980, section 2(4).

The National Health Service (General Dental Services) Regulations 1973.

The National Health Service (General Medical and Pharmaceutical Services) Regulations 1974.

The National Health Service (General Ophthalmic Services) Regulations 1974.

The National Health Service (Service Committees and Tribunal) Regulations 1974.

The National Health Service (Charges for Drugs and Appliances) Regulations 1980.

- 2. Subject to the provisions of paragraph 4 below any such arrangements made by an Area Health Authority and in operation immediately before 1st April 1982 shall, so far as they relate to any practitioner whose practice premises are in the district of the District Health Authority (or of any of the District Health Authorities) by which a new Committee is established or adopted, or to any general medical practitioner's patient whose address is in that district, continue in operation thereafter notwithstanding the dissolution of that Area Health Authority as if made by the District Health Authority (or Authorities) in question.
- 3. Subject to the provisions of paragraph 4 below all arrangements made, things done and procedures commenced before 1st April 1982 by or in relation to a Family Practitioner Committee established by an Area Health Authority, in connection with the administration of arrangements made pursuant to the provisions specified in the Table above or the exercise of any function conferred or imposed by or under those provisions, shall, so far as they relate to any practitioner whose practice premises are in the district of the District Health Authority (or of any of the District Health Authorities) by which a new Committee is established, or to any general medical practitioner's patient whose address is in that district, have effect thereafter as if made, done or commenced by or in relation to the new Committee and may, where the case so requires or permits, be continued accordingly by or in relation to that Committee.

- 4. Notwithstanding the provisions of paragraphs 2 and 3 above—
- (a) a practitioner with whom arrangements for the provision of services have been made before 1st April 1982 under or by virtue of the provisions of Part II of the said Act of 1977 may, if he does not wish those arrangements to continue with a new Committee or with the District Health Authority (or Authorities) by which it is established, give notice in writing to that effect to that Committee and thereupon the provisions of the relevant regulations specified in the Table above relating to the termination of arrangements shall apply accordingly;
- (b) a general medical practitioner shall not by virtue only of the provisions of this Schedule become entitled to provide services under or by virtue of the provisions of Part II of the said Act of 1977 at any place within the district of a District Health Authority unless he was entitled to provide those services at that place immediately before 1st April 1982.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order makes such modifications of instruments and enactments referring to Area Health Authorities as seem necessary having regard to the replacement of Area Health Authorities by District Health Authorities by virtue of section 1 of the Health Services Act 1980.
