Now, therefore, Her Majesty, by virtue and in exercise of the powers conferred on Her by section 1(3) of the European Communities Act 1972 or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1. This Order may be cited as the European Communities (Definition of Treaties) (ECSC Decision of 7th December 1981 on Supplementary Revenue) Order 1982 and shall come into operation on the day after it is made.
