# The Control of Pollution Act 1974 (Commencement No. 15) (Scotland) Order 1982

Made - - - - 21st April 1982

In exercise of the powers conferred on me by section 109(2) of the Control of Pollution Act 1974(a) and of all other powers enabling me in that behalf, I hereby make the following order:—

#### Citation and commencement

1. This order may be cited as the Control of Pollution Act 1974 (Commencement No. 15) Order 1982.

#### Interpretation

2. The provisions of the Control of Pollution Act 1974 (hereinafter referred to as "the Act") which are specified in column 1 of the Schedule to this order and which relate to the subject matter specified in column 2 thereof shall come into force in respect of Scotland only on 1st August 1982.
