# The Lake District Special Planning Board (Amendment) Order 1982

Made - - - - - Coming into Operation

13th July 1982 19th August 1982

The Secretary of State for the Environment, in exercise of the powers conferred by section 266 of, and paragraph 3 of Schedule 17 to, the Local Government Act 1972 (a), hereby orders as follows:—

- 1. This order may be cited as the Lake District Special Planning Board (Amendment) Order 1982, and shall come into operation on 19th August 1982.
- 2. The Lake District Special Planning Board Order 1973 (b) is hereby amended as follows:—
  - (a) In article 2, after the definition of "the Joint Board" there shall be inserted the following definition—
    - "the relevant district council" means the council of any district part of which is comprised in the United District;".
  - (b) In article 3, for paragraph (2) there shall be substituted the following paragraph—
    - "(2) The Special Planning Board shall consist of 30 members: 16 members (hereinafter called "the county council members") shall be appointed by the County Council of Cumbria, 4 members (hereinafter called "the district council members") shall be appointed by district councils in accordance with paragraph 12A of Schedule 17 to the Act, and 10 members (hereinafter called "the non-elective members") shall be appointed by the Secretary of State after consultation with the Countryside Commission.".
  - (c) Article 5 shall be omitted.
  - (d) In article 6-
    - (i) in paragraph (1), for the word "elective" in both places where it occurs, there shall be substituted the words "county council";
    - (ii) for paragraph (4), there shall be substituted the following paragraph—
      - "(4) Any casual vacancy shall be filled as soon as practicable, and the person appointed shall hold office for the remainder of the term of office of the person in whose place he is appointed.":
    - (iii) in paragraph (5), for the word "elective" there shall be substituted the words "county and district council".
  - (e) In article 8(3), for the words "with a district council the whole or any part of whose area lies within the United District" there shall be substituted the words "with a relevant district council".

# (f) In article 11—

- (i) in paragraph (1), for the words "and to the County Council of Cumbria" there shall be substituted the words "to the County Council of Cumbria and to every relevant district council";
- (ii) in paragraph (4), for the words "and to the said Council" there shall be substituted the words "to the said Council and to every relevant district council".

# (g) In Schedule 1-

- (i) in paragraph 5(3)(b), after the words "County Council of Cumbria" there shall be inserted the words "and to every relevant district council";
- (ii) in paragraph 6, for the number "9" there shall be substituted the number "10";
- (iii) in paragraph 7(1), after the words "County Council of Cumbria" there shall be inserted the words "and to every relevant district council".
