**The Rating (Repayment Procedures etc.) (Scotland) Amendment
Regulations 1983**

In exercise of the powers conferred on me by section 111(1) of the Local Government (Scotland) Act 1973(a), and of all other powers enabling me in that behalf, and after consultation with such associations of local authorities as appear to me to be concerned, I hereby make the following regulations:—

1. These regulations may be cited as the Rating (Repayment Procedures etc.) (Scotland) Amendment Regulations 1983 and shall come into operation on 28th July 1983.

2. In the Rating (Repayment Procedures etc.) (Scotland) Regulations 1981(b)—

- (a) after the words “Local Government (Scotland) Act 1973” where they appear in regulations 2 and 4 respectively, there shall be inserted the words “or determine or are deemed to have determined a lower rate under section 5(4)(b) of the Local Government (Scotland) Act 1966(c)”;
- (b) after the word “Act” in the fifth line of regulation 2, there shall be inserted the words “of 1973”;
- (c) after the word “determination” in regulation 4, there shall be inserted the words “or deemed determination”.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Rating (Repayment Procedures etc.) (Scotland) Regulations 1981 and prescribe that the provisions for repayment or credit of any sums as the result of the determination of a lower rate by a local authority, and for the extra cost of levying that lower rate to be borne by that local authority, shall apply when a new rate is determined or deemed to be determined under section 5(4)(b) of the Local Government (Scotland) Act 1966.
