The Butter Subsidy (Protection of Community Arrangements) (Amendment) Regulations 1983

Made	25th July 1983
Laid before Parliament	2nd August 1983
Coming into Operation	23rd August 1983

The Minister of Agriculture, Fisheries and Food and the Secretary of State, being Ministers designated (a) for the purposes of section 2(2) of the European Communities Act 1972 (b) in relation to the common agricultural policy of the European Economic Community, acting jointly in exercise of the powers conferred on them by the said section 2(2) and of all other powers enabling them in that behalf, hereby make the following regulations:-

Title and commencement

1. These regulations may be cited as the Butter Subsidy (Protection of Community Arrangements) (Amendment) Regulations 1983 and shall come into operation on 23rd August 1983.

Amendment of the Butter Subsidy (Protection of Community Arrangements) Regulations 1980

- The Butter Subsidy (Protection of Community Arrangements) Regulations 1980 (c) shall be further amended by substituting in regulation 1(2) thereof for the definition of "subsidy payment" the following definition:-
 - "'subsidy payment' means a sum paid in pursuance of any of the following provisions:

Council Regulation (EEC) No. 2574/78 (d) on the granting of aid for consumption of butter in the United Kingdom;

Council Regulation (EEC) No. 1269/79 (e) on the marketing of reducedprice butter for direct consumption as amended by Council Regulation (EEC) No. 1362/80 (f), Council Regulation (EEC) No. 854/81 (g) and Council Regulation (EEC) No. 1186/82 (h);

Commission Regulation (EEC) No. 2991/82 (i) on the temporary marketing during the 1982/83 milk year of reduced-price butter for direct consumption;

Council Regulation (EEC) No. 1208/83 (j) further amending Council Regulation (EEC) No. 1269/79 on the marketing of reduced-price butter for direct consumption."

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations further amend the Butter Subsidy (Protection of Community Arrangements) Regulations 1980 by substituting a new definition of "subsidy payment" in regulation 1(2) thereof. The purpose of the amendment is to incorporate a reference to the current Community instrument: Council Regulation (EEC) No. 1208/83 of 17 May 1983 amending Regulation (EEC) No. 1269/79 as regards the conditions for the marketing of reduced-price butter for direct consumption during the 1983/84 milk year.

The main effect of the amendment is to apply the provisions of the principal regulations to payments made in pursuance of Council Regulation (EEC) No. 1269/79 as extended to the milk year 1983/84 by Council Regulation (EEC) No. 1208/83.
