**1983 No. 1681 (L.25)****COUNTY COURTS****The County Court Fees (Amendment) Order 1983**

*Made* - - - - 14th November 1983

*Laid before Parliament* 15th November 1983

*Coming into Operation* 12th December 1983

The Lord Chancellor, in exercise of the powers conferred on him by section 177 of the County Courts Act 1959(a), with the concurrence of the Treasury, hereby makes the following Order:—

1. (1) This Order may be cited as the County Court Fees (Amendment) Order 1983 and shall come into operation on 12th December 1983.

(2) A fee or column referred to by number means the fee or column so numbered in Schedule 1 to the County Court Fees Order 1982(b).

2. In column 2 (amount of fee) —

- (a) in Fee 1(i), for “£5”, “£32”, “£34”, and “£35” there shall be substituted “£6”, “£35”, “£38”, and “£40” respectively;
- (b) in Fee 1(ii), for “£15” there shall be substituted “£20”;
- (c) in Fee 2, for “£4” there shall be substituted “£5”;
- (d) in Fee 4(i), for “£3.50” and “£25” there shall be substituted “£5” and “£30” respectively;
- (e) in Fee 4(ii), for “£5” there shall be substituted “£6”;
- (f) in Fee 4(vi), for the whole entry there shall be substituted “£10”;
- (g) in Fee 4(vii), for “£2.50” and “£15” there shall be substituted “£5” and “£20” respectively;
- (h) in Fee 7(ii)(b), for “£17” there shall be substituted “£20”.

3. In column 3 (method of charging fee) —

- (a) under Fee 1(ii), for “£35” there shall be substituted “£40”;
- (b) under Fee 4(iii), the whole note shall be omitted;
- (c) under Fee 4(viii), the whole note shall be omitted.

4. Fee 4(iv) shall be omitted and the following substituted: —

“(iv) By the issue of a warrant of possession . . .	£20	4.(iv) Where the recovery of a sum of money, other than this fee, is sought in addition, the appropriate fee under Fee 4(i) is also payable.”
