# CHILDREN AND YOUNG PERSONS

# The Children Act 1975 and the Adoption Act 1976 (Commencement) Order 1983

Made - - - 22nd December 1983

The Secretary of State for Social Services, in exercise of the powers conferred upon him by section 108(2) and (8) of the Children Act 1975 (a) and section 74(2) of the Adoption Act 1976 (b) and of all other powers enabling him in that behalf, hereby makes the following order:—

#### Citation, extent and interpretation

- 1.—(1) This order may be cited as the Children Act 1975 and the Adoption Act 1976 (Commencement) Order 1983.
  - (2) This order shall not apply to Scotland.
  - (3) In this order—

"the Act" means the Children Act 1975;

"the 1958 Act" means the Adoption Act 1958 (c).

Day appointed for the coming into force of certain provisions of the Act and sections 58A and 74 of the Adoption Act 1976

- 2.—(1) The provisions of the Act specified in the first column of Schedule 1 to this order and of each of the two appendices to that Schedule (which relate to the matters specified in the second column thereof) shall come into force on 27th May 1984.
- (2) Sections 58A (information concerning adoption)(d) and 74 (short title, commencement and extent) of the Adoption Act 1976 shall come into force on 27th May 1984.

# Transitional provisions and adaptations

3. The transitional provisions and adaptations contained in Schedule 2 to this order shall have effect in connection with the provisions brought into force by this order.

#### SCHEDULE 2

#### Transitional Provisions and Adaptations

- 1. In this Schedule "relevant date" means 27th May 1984.
- 2. Where an application for an adoption order has been made before the relevant date and has not been determined by that date, the provisions of sections 9, 18, 19, 20(1) to (3), 22(1) and (3) and 102(1) and (2) of the Act shall, notwithstanding that they have been brought into force by this order, not apply in connection with that application.
- 3. Where an application for a provisional adoption order has been made before the relevant date and has not been determined by that date, the provisions of sections 9, 18, 19, 20(1) to (3), 22(3) and 25 of, and paragraph 36(a) of Schedule 3 to, the Act shall, notwithstanding that they have been brought into force by this order, not apply in connection with that application.
- 4. Where immediately before the relevant date the provisions of section 36 of the 1958 Act applied in respect of a child in the care of a local authority, that section shall apply in respect of that child as if paragraph 30(a) of Schedule 3 to the Act had not been brought into force by this order.
- 5. In relation to a child who immediately before the relevant date is a protected child within the meaning of Part IV of the 1958 Act, section 37 of that Act shall apply as if paragraph 31(a) of Schedule 3 to the Act and Part XI of Schedule 4 thereto insofar as they relate to that section had not been brought into force by this order.
- 6. Where, in relation to an application for an adoption order made before the relevant date, an interim order has been made under section 8 of the 1958 Act and that order is in force immediately before the relevant date, section 19 of the Act shall, notwithstanding that it has been brought into force by this order, not apply in connection with that application.
- 7. Where a provisional adoption order has been made under section 53 of the 1958 Act and that order is in force immediately before the relevant date, section 52 of that Act shall apply as if paragraph 36(a) of Schedule 3 to the Act had not been brought into force by this order.
- 8. Until the coming into force of section 1 of the Act, Part I thereof shall be subject to the following adaptations:—
  - (a) in sections 9, 14, 15, 16, 18, 20, 22 and 23 for the words "adoption agency" wherever they occur there shall be substituted the words "approved adoption society or local authority"; and
  - (b) in sections 9, 14, 15, 22 and 23 for the word "agency" wherever it occurs there shall be substituted the words "society or authority".

#### **EXPLANATORY NOTE**

(This Note is not part of the Order.)

This Order brings into force on 27th May 1984 the provisions of the Children Act 1975 specified in Schedule 1 and its appendices to the order, subject to the transitional provisions and adaptations contained in Schedule 2 thereto. The order also brings into force sections 58A and 74 of the Adoption Act 1976. This order does not extend to Scotland.
