The Dairy Produce Quotas (Definition of Base Year Revision Claims) Regulations 1984

Laid before Parliament in draft

Made - - - - 23rd July 1984 Coming into Operation 24th July 1984

The Minister of Agriculture, Fisheries and Food and the Secretary of State, being Ministers designated (a) for the purposes of section 2(2) of the European Communities Act 1972 (b) in relation to the common agricultural policy of the European Economic Community, acting jointly in exercise of the powers conferred on them by that section and of all other powers enabling them in that behalf, hereby make the following regulations a draft of which was laid before Parliament and approved by resolution of each House:—

Title and commencement

1. These regulations may be cited as the Dairy Produce Quotas (Definition of Base Year Revision Claims) Regulations 1984 and shall come into operation on the day after the day on which they are made.

Definition of base year revision claims

- 2.—(1) Paragraph (2) of this regulation shall have effect for the purposes of paragraph 9(1) and (2) of Schedule 1 and paragraph 8(1) and (2) of Schedule 2 to the Dairy Produce Quotas Regulations 1984(c) (which between them require the Minister to reject a special case claim unless it is a base year revision claim or a development claim).
- (2) An applicant's special case claim which relies on the first indent (which deals with serious natural disasters having a substantial effect) of Article 3(3) of Council Regulation (EEC) No. 857/84(d) adopting general rules for the application of the supplementary levy in the milk and milk products sector, in circumstances where the serious natural disaster is caused by weather, shall be a base year revision claim if, and only if, milk production on his holding was reduced in his base period by that disaster by no less than 15 per cent.
- (3) In this regulation "applicant", "base period", "base year revision claim", "development claim", "holding", "special case claim" and "the Minister" have the respective meanings assigned to them by regulation 2(1) of the Dairy Produce Quotas Regulations 1984.

EXPLANATORY NOTE

These regulations define base year revision claims under the Dairy Produce Quotas Regulations 1984 by excluding claims relying on serious natural disasters caused by weather resulting in a reduction of less than 15 per cent in an applicant's milk production.
