## HOUSING, ENGLAND AND WALES

# The Housing (Right to Buy) (Prescribed Persons) Order 1984

Made - - - - 1st August 1984
Laid before Parliament 3rd August 1984
Coming into Operation 26th August 1984

The Secretary of State for the Environment, as respects England, and the Secretary of State for Wales, as respects Wales, in exercise of the powers conferred on them by section 151(3) of, and paragraphs 9(2) and 10(2) of Schedule 1A to, the Housing Act 1980(a), and of all other powers enabling them in that behalf, hereby make the following order:—

- 1.—(1) This order may be cited as the Housing (Right to Buy) (Prescribed Persons) Order 1984 and shall come into operation on 26th August 1984.
  - (2) In this order "Schedule 1A" means Schedule 1A to the Housing Act 1980.
- 2. The persons listed in the Schedule to this order and any predecessor of any of those persons are hereby prescribed for the purposes of paragraphs 9(2) and 10(2) of Schedule 1A.
- 3.—(1) Subject to paragraph (2) below, all circumstances are prescribed for the purposes of paragraphs 9(2) and 10(2) of Schedule 1A.
- (2) The prescribed circumstances for the purposes of paragraph 9(2) of Schedule 1A do not include the following circumstances—
  - (a) if the interest of the landlord belongs to a Minister of the Crown or government department, any case where the dwelling-house is let to a person appointed under section 3(1) of the Prison Act 1952(b); and
  - (b) if the interest of the landlord belongs to the Trinity House, any case where the dwelling-house is held otherwise than in connection with its functions as a general light-house authority within the meaning of section 634 of the Merchant Shipping Act 1894(c).

## **EXPLANATORY NOTE**

(This note is not part of the order.)

Under the Housing Act 1980 qualification for the right to buy and entitlement to discount depend on periods spent as a tenant of a public sector landlord. The Act also requires discount obtained on a previous purchase from a public sector landlord to be taken into account in calculating discount on a later purchase under the right to buy. Paragraph 9(2) of Schedule 1A to the Act lists certain persons who are to be treated as public sector landlords for these purposes. This order prescribes certain additional persons who are also to be treated as public sector landlords for these purposes (article 2 and the Schedule). It also prescribes the circumstances in which they are to be so treated (article 3).
