The Control of Movement of Goods Regulations 1984

Interpretation

3. In these Regulations—

“the Act” means the Customs and Excise Management Act 1979;

“approved place” —

- (a) in relation to imported goods means a place approved by the Commissioners under section 20 or 25 of the Act for [^{F1}facilitating the administration, collection or enforcement of any duty of customs], and
- (b) in relation to goods intended for export means a place appointed under section 159 of the Act for the examination of goods which is approved by the Commissioners under section 31 of the Act for the examination of such goods before their movement to a place of exportation;

“the loader” [^{F2}means] the owner of the [^{F3}vehicle] in which the goods are to be exported or a person appointed by him;

“place of importation” and “place of exportation” shall, where appropriate, include a free zone;

“removal” means a movement of goods which is authorised under these Regulations and “remove” and “removed” shall be construed accordingly;

“removal document” means a document to be obtained from or approved by the Commissioners made in such form and containing such particulars as the Commissioners may direct under section 31(2A) of the Act and for the purpose of regulation 16 shall include a copy of the application referred to in regulations 5 ^{F4}... and 7 stamped by the proper officer.

4.—(1) These Regulations shall not apply where any goods are moved under the [^{F5}common transit procedure as defined in paragraph 1(2) of Schedule 1 to the Customs Transit Procedures (EU Exit) Regulations 2018].

(2) The application of regulations 11 and 13 of these Regulations to goods carried under the provisions of an international convention having effect in the United Kingdom shall be without prejudice to any such provisions.
