The Veterinary Surgeons and Veterinary Practitioners Registration (Amendment) Regulations Order of Council 1984

Made - - 21st December 1984

At the Council Chamber, Whitehall, the 21st day of December 1984 By the Lords of Her Majesty's Most Honourable Privy Council

Whereas in pursuance of section 11 of the Veterinary Surgeons Act 1966(a) the Council of the Royal College of Veterinary Surgeons have made regulations entitled "The Veterinary Surgeons and Veterinary Practitioners Registration (Amendment) Regulations 1984";

And whereas by section 25(1) of the said Act such regulations shall not have effect unless approved by Order of the Privy Council:

Now, therefore, Their Lordships, having taken the said regulations into consideration, are hereby pleased to approve the same as set out in the Schedule to this Order.

This Order may be cited as the Veterinary Surgeons and Veterinary Practitioners Registration (Amendment) Regulations Order of Council 1984.

SCHEDULE

THE VETERINARY SURGEONS AND VETERINARY PRACTITIONERS
REGISTRATION (AMENDMENT) REGULATIONS 1984

The Council of the Royal College of Veterinary Surgeons, in exercise of their powers under section 11 of the Veterinary Surgeons Act 1966, hereby make the following Regulations —

- 1. These Regulations may be cited as the Veterinary Surgeons and Veterinary Practitioners Registration (Amendment) Regulations 1984.
- 2. Regulation 16 of the Veterinary Surgeons and Veterinary Practitioners Registration Regulations 1967(b) as amended, (hereinafter referred to as "the principal Regulations") shall be further amended by the deletion of the second sentence and the substitution of the following therefor —

"This fee shall be paid at the time of the application for registration and shall be £52.50 for names entered on the register before 31st March 1985 and £80 for names entered on the register on 31st March 1985 and thereafter."

- 3. Regulation 20 of the principal Regulations shall be amended by the deletion in paragraphs (a), (b), (c), (d) and (e) of the amounts "£45.00", "£13.00", "£1.00", "£8.50" and "£4.50" and the substitution therefor of the amounts "£70.00", "£20.50", "£5.00", "£13.00" and "£7.00" respectively.
- 4. Regulation 22 of the principal Regulations shall be amended by the deletion of the amounts "£6.00" and "£3.00" and the substitution therefor of the amounts "£10.00" and "£5.00" respectively.
- 5. Regulation 23 of the principal Regulations shall be amended by the deletion in the first and third sentence of paragraph (b) of the amount "£52.50" and the substitution therefor in each case of the amount "£80.00".

EXPLANATORY NOTE

(This Note is not part of the Order.)

The regulations approved by this Order further amend the Veterinary Surgeons and Veterinary Practitioners Registration Regulations 1967 by increasing by about 15% the fees payable in respect of the registration and retention of names in, or the restoration of names to, the registers kept by the Royal College of Veterinary Surgeons. The existing fees were fixed in 1981.
