# The Police Cadets (Scotland) Amendment Regulations 1984

Made	20th December 1984
Laid before Parliament	10th January 1985
Coming into Operation	31st January 1985

In exercise of the powers conferred on me by section 27 of the Police (Scotland) Act 1967(a), and of all other powers enabling me in that behalf, and after taking into consideration the recommendations made by the Police Negotiating Board for the United Kingdom and furnishing the said Board with a draft of the regulations in accordance with section 2(1) of the Police Negotiating Board Act 1980 (b), I hereby make the following regulations:—

## Citation

1. These regulations may be cited as the Police Cadets (Scotland) Amendment Regulations 1984.

#### Interpretation

2. In these regulations any reference to "the principal regulations" is a reference to the Police Cadets (Scotland) Regulations 1968 (c).

## Operation and effect

- 3. These regulations shall come into operation on 31st January 1985 and shall have effect—
  - (a) for the purposes of regulations 4, 7, 8 and 9(b), as from 31st January 1985:
  - (b) for the purposes of regulation 5, as from 25th October 1984;
  - (c) for the purposes of regulations 6 and 9(a), as from 1st September 1984.

#### **Amendments**

- 4. For paragraphs (1) and (1A) of regulation 16 of the principal regulations (Uniform and equipment) there shall be substituted the following paragraph:—
  - "(1) Subject to the following provisions of this regulation, the police authority shall supply a police cadet with 2 pairs of boots or shoes annually for the purposes of normal duty and with such other items of uniform and equipment as are requisite in his case, and shall provide for the dry cleaning of uniform and the repair of footwear.".
- 5. In paragraph (1B) of regulation 16 of the principal regulations, for the sum "£22" there shall be substituted the sum "£25".

6. For the Table in Schedule 1 to the principal regulations (which contains scales of pay) there shall be substituted the following table:—

Age	Annual Pay	
Under 17 years	£2,646	
17 years	£2,805	
18 years or over	£3,123	

7. In Schedule 2 to the principal regulations (which relates to charges for board and lodging), for the sum "£354" there shall be substituted the sum "£369".

# Revocations

- 8. Regulation 5(1) of the Police Cadets (Scotland) Amendment Regulations 1974 (a) and regulation 5 of the Police Cadets (Scotland) Amendment Regulations 1977 (b) (which relate to the footwear allowance) are hereby revoked.
- 9. The following regulations of the Police Cadets (Scotland) Amendment (No. 2) Regulations 1983(c) are hereby revoked:—
  - (a) regulation 4 (which relates to scales of pay) and
  - (b) regulation 5 (which relates to charges for board and lodging).

## **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

These regulations further amend the Police Cadets (Scotland) Regulations 1968.

Regulation 4 amends regulation 16 of the 1968 Regulations, with effect from 31st January 1985, so as to provide for the issue of footwear to all cadets and for the withdrawal of the footwear allowance.

Regulation 5 increases the stockings allowance for woman police cadets from £22 per year to £25 per year with effect from 25th October 1984.

Regulation 6 increases the pay of police cadets with effect from 1st September 1984. The retrospective effect of these regulations is authorised by section 27(2) of the Police (Scotland) Act 1967.

Regulation 7 increases the charges payable by cadets for board and lodging provided by police authorities from £354 per annum to £369 per annum with effect from 31st January 1985.
