## NATIONAL HEALTH SERVICE, ENGLAND AND WALES

The National Health Service (Dental and Optical Charges)  
Amendment Regulations 1984

The Secretary of State for Social Services, in exercise of powers conferred by sections 78(1) and 79 of and paragraphs 2(1) and (2), and 3(1), (2) and (3) of Schedule 12 to the National Health Service Act 1977(a) and of all other powers enabling him in that behalf, hereby makes the following regulations:—

*Citation and commencement*

1. These regulations may be cited as the National Health Service (Dental and Optical Charges) Amendment Regulations 1984 and shall come into operation on 1st April 1984.

*Amendment to Regulations*

2. The National Health Service (Dental and Optical Charges) Regulations 1978(b) are further amended as follows—

- (a) in regulation 4(1) for “£50” there is substituted “£59”, for “£26” there is substituted “£30” and for “£13.50” there is substituted “£14.50”;
- (b) in regulation 6 for “£13.50” there is substituted “£14.50” and for “£95” there is substituted “£110”;
- (c) in regulation 7(2) for “95p” there is substituted “£1.00”;
- (d) in regulation 7(4) for “£15.50” there is substituted “£16.50”;
- (e) for Schedule 1 there is substituted the following Schedule:—

(a) 1977 c. 49; paragraphs 2 and 3 of Schedule 12 were amended by the Health Services Act 1980 (c. 53), Schedule 5, paragraphs 2 and 3 respectively.

1. A metal or porcelain based denture— having 1 to 3 teeth	£47.00
having 4 to 8 teeth	£49.00
having more than 8 teeth	£51.00
2. More than one metal or porcelain based denture	£92.00
3. A denture based in material other than metal or porcelain— having 1 to 3 teeth	£24.00
having 4 to 8 teeth	£26.00
having more than 8 teeth	£28.00
4. More than one denture based in materials other than metal or porcelain	£44.00

*Note:* A bridge which takes the place of any teeth is deemed to be a denture having that number of teeth (a).";

*Application*

3. These regulations shall apply only in relation to—

- (a) the supply of dental or optical appliances otherwise than under Part II of the National Health Service Act 1977 where the examination or testing of sight, or the first such examination or testing, leading to such supply takes place after 31st March 1984;

- 
- (b) the provision of general dental services where the contract or arrangement leading to the supply as part of those services of a dental appliance or to the provision other than such supply of dental services is made after that date;
- (c) the supply of optical appliances under Part II of that Act where the testing of sight leading to the supply of those appliances or the first such testing takes place after that date.
