**The Civic Government (Scotland) Act 1982 (Commencement)  
(Amendment No. 2) Order 1984**

*Made* - - - -

*6th June 1984*

In exercise of the powers conferred on me by section 137(2) of the Civic Government (Scotland) Act 1982(a), and of all other powers enabling me in that behalf, I hereby make the following order:—

1.—(1) This order may be cited as the Civic Government (Scotland) Act 1982 (Commencement) (Amendment No. 2) Order 1984.

(2) In this order, unless the context otherwise requires, “the Act” means the Civic Government (Scotland) Act 1982.

2. Article 3 of the Civic Government (Scotland) Act 1982 (Commencement) Order 1983(b) shall not apply to the provisions of the Act specified in articles 3 and 4 of this order in their application to the areas of the local authorities referred to therein.

3. The provisions of sections 9 to 27 and 38 to 44 of the Act (Licensing and Regulation – Particular Activities) shall, in so far as not already fully in force, come into operation as respects the area of—

- (a) Lochaber District Council, on 2nd August 1984,
- (b) the City of Glasgow District Council, on 20th August 1984,
- (c) Wigtown District Council, on 20th September 1984, and
- (d) Cunninghame District Council, on 1st November 1984.

4. The provisions of sections 24 to 27 and 38 to 44 of the Act (Licensing and Regulation – Particular Activities, other than Licensing and Regulation of Taxis

and Private Hire Cars) shall, in so far as not already fully in force, come into operation in the area of Monklands District Council, on 1st January 1985.

EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This order postpones, for the areas of the local authorities referred to in the order, the date fixed by the Civic Government (Scotland) Act 1982 (Commencement) Order 1983 as the date on which the optional licensing provisions are brought fully into operation. In the case of the four authorities named in article 3, this order postpones the date on which all such provisions are brought fully into operation from 1st July 1984 to the dates specified in the order for each authority. Article 4 of the order postpones from 1st July 1984 to 1st January 1985 the date on which the optional licensing provisions other than taxi licensing and regulation are brought fully into operation for the area of Monklands District Council. By the making of this order, the repeal of the existing legislation currently in force in these areas and corresponding to the optional licensing provisions is also postponed to the dates specified in the order, in terms of sections 137(3) of the Civic Government (Scotland) Act 1982.
