**The Explosives (Licensing of Stores and Registration of Premises)
Fees Regulations 1985**

The Secretary of State, in exercise of the powers conferred on him by section 15(1) and (3)(a) of the Health and Safety at Work etc. Act 1974 (a) (“the 1974 Act”) and of all other powers enabling him in that behalf and for the purpose of giving effect without modifications to proposals submitted to him by the Health and Safety Commission under section 11(2)(d) of the 1974 Act after the carrying out by the said Commission of consultations in accordance with section 50(3) of that Act, hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Explosives (Licensing of Stores and Registration of Premises) Fees Regulations 1985 and shall come into operation on 19th August 1985.

Amendment of the Explosives Act 1875

2. The Explosives Act 1875 (b) shall be amended as follows—
- (a) in section 15 (which provides for the maximum fee payable for a store licence) for “£30” (c) substitute “£36”;
 - (b) in section 18 (which provides for the maximum fee payable for the renewal of a store licence) for “£30” (c) substitute “£36”;
 - (c) in section 21 (which provides for the maximum fees payable for the registration, and renewal of registration, of premises used for the keeping of explosives) for “£5” (c), in each place where it occurs, substitute “£6”.

Revocation

3. The Explosives (Licensing of Stores and Registration of Premises) Fees Regulations 1983 (d) are hereby revoked.

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend sections 15, 18 and 21 of the Explosives Act 1875 which, as previously amended by the Explosives (Licensing of Stores and Registration of Premises) Fees Regulations 1983, provide for the maximum fees payable to a local authority for the licensing of a store or the registration of premises used for the keeping of explosives.

The maximum fee payable for a store licence, including the renewal thereof, is increased from £30 to £36. The maximum fee payable for the registration, and renewal of registration, of premises is increased from £5 to £6.

The Explosives (Licensing of Stores and Registration of Premises) Fees Regulations 1983 are revoked.
