**1985 No. 1188****SOCIAL SECURITY****The Family Income Supplements (Computation) Regulations 1985***Laid before Parliament in draft**Made* - - - - - *29th July 1985**Coming into Operation* *26th November 1985*

The Secretary of State for Social Services, in exercise of the powers conferred on him by sections 2(1), 3(1) and (1A) and 10(3A) of the Family Income Supplements Act 1970(a), and of all other powers enabling him in that behalf, hereby makes the following regulations of which a draft has, in accordance with section 10(5) of that Act, been laid before Parliament and approved by resolution of each House of Parliament:—

*Citation and commencement*

1. These regulations may be cited as the Family Income Supplements (Computation) Regulations 1985 and shall come into operation on 26th November 1985.

*Prescribed amount*

2.— (1) The prescribed amount for any family for the purposes of section 1(2) of the Family Income Supplements Act 1970 shall be the amount specified in paragraph (2) or (3) below as the case may be.

(2) Where the family includes only one child, the prescribed amount shall be—

- (a) £97.50, if the child is aged under 11; or
- (b) £98.50, if the child is aged under 16 but not less than 11; or
- (c) £99.50, if the child is aged 16 or over.

(3) Where the family includes more than one child, the prescribed amount

shall be the aggregate of whatever would be applicable under paragraph (2) above if the first child were the only child plus, for each additional child—

- (a) aged under 11, £11.50;
- (b) aged under 16 but not less than 11, £12.50;
- (c) aged 16 and above, £13.50.

*Maximum amount of family income supplement*

3.— (1) The weekly rate of family income supplement shall not exceed the amount specified in paragraph (2) or (3) below as the case may be.

(2) Where the family includes only one child, the weekly rate of family income supplement shall not exceed—

- (a) £25, if the child is aged under 11; or
- (b) £25.50, if the child is aged under 16 but not less than 11; or
- (c) £26, if the child is aged 16 or over.

(3) Where the family includes more than one child, the weekly rate of family income supplement shall not exceed the aggregate of whatever would be applicable under paragraph (2) above, if the first child were the only child plus, for each additional child—

- (a) aged under 11, £2.50;
- (b) aged under 16 but not less than 11, £3;
- (c) aged 16 and above, £3.50.

*Revocation*

4. The Family Income Supplements (Computation) Regulations 1984(a) are hereby revoked.

## EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

Sections 2 and 3 of the Family Income Supplements Act 1970 provide for family income supplement to bring a family's weekly resources up to one half of the amount prescribed by regulations, but subject to a prescribed maximum. These Regulations increase the amounts prescribed and also increase the maximum.

The amounts currently prescribed for a family are £90, plus £10 for any child additional to the first. In place of these regulation 2 now prescribes—

- (a) £97.50 for a family whose first or only child is under 11, plus £11.50 for every other such child;
- (b) £98.50 for a family whose first or only child is between 11 and 16, plus £12.50 for every other such child and £11.50 for every child under 11;
- (c) £99.50 for a family whose first or only child is 16 or over, plus £13.50 for every other such child, £12.50 for every child between 11 and 16 and £11.50 for every child under 11.

The current maximum weekly rate for a family is £23 plus £2 for every child additional to the first. In place of these figures regulation 3 now prescribes as the maximum weekly rates £25 for a family in group (a), above, £25.50 for a family in group (b) and £26 for a family in group (c), plus, for every child after the first, £3.50 if the child is 16 or over, £3 if the child is between 11 and 16 and £2.50 if the child is under 11.
