


The Secretary of State for Transport makes this Instrument in exercise of powers conferred by sections 106(3) and 325 of the Highways Act 1980(a) and now vested in him(b) and of all other enabling powers:—

- 1. The Buckinghamshire County Council H5 Portway (Canal Bridge) Scheme 1984 is hereby confirmed without modifications.
- 2. The said Scheme as confirmed (hereinafter referred to as "the Scheme") is set out in the Schedule hereto and copies of the Scheme with its accompanying plans are deposited at the offices of the Department of Transport, and at the offices of the Buckinghamshire County Council, County Hall, Aylesbury.
- 3. The scheme will become operative on the date on which notice that it has been confirmed is first published in accordance with paragraph 1 of Schedule 2 to the Highways Act 1980.
- 4. This Instrument may be cited as the Buckinghamshire County Council H5 Portway (Canal Bridge) Scheme 1984 Confirmation Instrument 1985.

SCHEDULE

THE BUCKINGHAMSHIRE COUNTY COUNCIL H5 PORTWAY (CANAL BRIDGE) SCHEME 1984

THE COUNTY COUNCIL of BUCKINGHAMSHIRE (hereinafter referred to as "the Council") make this Scheme in exercise of their powers under Section 106 of the Highways Act 1980 and of all other enabling powers:—

- 1. The Council are authorised to construct over the navigable waters of the Grand Union Canal at Willen Milton Keynes in the County of Buckinghamshire the bridge specified in the Schedule to this Scheme as part of the highway which they are proposing to construct between the V9 highway and the V10 highway in the Borough of Milton Keynes in the said County.
- 2. This scheme may be cited as 'The Buckinghamshire County Council H5 Portway (Canal Bridge) Scheme 1984'.

Given under the Common Seal of the Council this 28th day of September 1984.

The location and specifications of the bridge are shown on drawing number 1D/5060/9 attached hereto and the construction of the bridge shall include:—

Span — 19 metres

Minimum waterway

width — 14 metres Headroom — 4.5 metres
