### PROSPECTIVE

1. These Regulations may be cited as the Motor Vehicles (Type Approval) (Great Britain) (Amendment) Regulations 1985, and shall come into operation on 2nd December 1985.

  - "(k) a motor vehicle for which a first licence was granted under the Vehicles (Excise) Act (Northern Ireland) 1972(3) on or after 2nd December 1985; or
  - (l) a motor vehicle in respect of which there exists a certificate issued in accordance with the provisions of Article 31A of the Road Traffic (Northern Ireland) Order 1981(4)
