The Health and Social Services and Social Security Adjudications Act 1983 (Scotland) (Commencement No. 1) Order 1985

Made - - - 29th April 1985

In exercise of the powers conferred upon me by section 32(2) of the Health and Social Services and Social Security Adjudications Act 1983(a), and of all other powers enabling me in that behalf, I hereby make the following order:—

Citation, extent and interpretation

- 1.—(1) This order may be cited as the Health and Social Services and Social Security Adjudications Act 1983 (Scotland) (Commencement No. 1) Order 1985 and shall extend only to Scotland.
- (2) In this order "the Act" means the Health and Social Services and Social Security Adjudications Act 1983.

2. The provisions of the Act specified in the first column of the Schedule to this order (which relate to the matters specified in the second column thereof) shall come into force on 1st May 1985.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order brings into force section 2 of the Health and Social Services and Social Security Adjudications Act 1983, ("the Act"), and repeals section 4(2) of the Health Services Act 1980, as from 1st May 1985.

Section 2 of the Act amends the National Health Service (Scotland) Act 1978 (c.29) by inserting a new section 16A to replace that which was inserted by section 4(2) of the Health Services Act 1980. The new section 16A extends the powers of health boards in Scotland by enabling them to make payments to local authorities, voluntary agencies and other specified bodies towards expenditure incurred by them with respect to the provision of housing accommodation and certain aspects of education, as well as social work services, and empowers the Secretary of State to prescribe by direction the conditions for such payments.

NOTE AS TO EARLIER COMMENCEMENT ORDERS

(This Note is not part of the Order.)

Other Commencement Orders have been made under the Act (S.I. 1983/974, 1862, 1984/216, 957, 1347, the last mentioned as amended by S.I. 1984/1767) and a Note listing the provisions brought into force by those orders can be obtained from the Information Division, Department of Health and Social Security, Alexander Fleming House, London SE1 6BY.

The remaining provisions of the Act for which Commencement Orders have still to be made are as follows: sections 21 to 24 (recovery of charges for local authority accommodation); and section 30(1) and Part I of Schedule 10 (repeals) as regards repeals connected with those outstanding provisions.
