CONSERVATION OF SEA FISH

The Sea Fishing (Specified Western Waters) (Restrictions on Landing) (Variation) Order 1986

Made - - - -18th August 1986Laid before Parliament26th August 1986Coming into Operation27th August 1986

The Minister of Agriculture, Fisheries and Food and the Secretaries of State respectively concerned with the sea fishing industry in Scotland, Wales and Northern Ireland, acting jointly, in exercise of the powers conferred on them by sections 6(1), 15(3) and 20(1) of the Sea Fish (Conservation) Act 1976 (a), and of all other powers enabling them in that behalf, after consultation with the Secretary of State for Trade and Industry, hereby make the following order:—

Title and commencement

1. This order may be cited as the Sea Fishing (Specified Western Waters) (Restrictions on Landing) (Variation) Order 1986, and shall come into operation on 27th August 1986.

Variation of the Sea Fishing (Specified Western Waters) (Restrictions on Landing) Order 1980

- 2. The Sea Fishing (Specified Western Waters) (Restrictions on Landing) Order 1980 (b) is hereby varied—
 - (a) by substituting in article 4(b) thereof for the words "less than 10 metres" the words "not more than 10 metres";
 - (b) by inserting in article 4(e) thereof after the words "specified sea fish" the words "except hake (Merluccius spp), megrim (Lepidorhombus whiffiagonis), Norway lobster (Nephrops norvegicus) or pollack (Pollachius pollachius)"; and
 - (c) by adding at the end of the Schedule 2 thereto the following descriptions of sea fish —
 - "Norway lobster (Nephrops norvegicus)
 Pollack (Pollachius pollachius)".

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order varies the Sea Fishing (Specified Western Waters) (Restrictions on Landing) Order 1980 as varied which prohibits, subject to exceptions, the landing of sea fish of descriptions specified in the order caught in ICES subareas VII or VIII.

This order —

- (a) modifies article 4(b) of that order to provide that the prohibition does not apply to fish caught by British fishing boats not more than 10 metres in length (article 2(a));
- (b) varies article 4(e) of that order, which excepts from the scope of that prohibition the landing of a quantity of one of the descriptions of fish subject to the order, caught otherwise than under the authority of a licence as a by catch not exceeding 10 per cent by weight of the landed catch in the course of lawful fishing for another description of sea fish, by removing from the scope of that exception the landing of a by catch of hake, megrim, Norway lobster or pollack (article 2(b)); and
- (c) adds Norway lobster and pollack to the descriptions of sea fish to which that prohibition applies (article 2(c)).
