HIGH COURT OF JUSTICIARY, SCOTLAND

Act of Adjournal (Circuits) 1986

Made - - - - 26th September 1986

Coming into Operation 20th October 1986

The Lord Justice General, Lord Justice Clerk and Lords Commissioners of Justiciary, by virtue of the powers conferred upon them by section 114 of the Criminal Procedure (Scotland) Act 1975(a), and of all other powers enabling them in that behalf, and after consultation with the Lord Advocate, do hereby enact and declare:—

Citation and commencement

1.—(1) This Act of Adjournal may be cited as the Act of Adjournal (Circuits) 1986 and shall come into operation on 20th October 1986.

(2) This Act of Adjournal shall be inserted in the Books of Adjournal.

Places and times of circuits

2.—(1) The circuits and sittings specified in column 1 of Schedule 1 to this Act of Adjournal shall be held during 1987 at the places, on the dates and at the times specified respectively in relation thereto in columns 2, 3, and 4 of that Schedule.

(2) Intimation under this paragraph shall be made by the Clerk of Justiciary to all sheriff clerks on the passing of this Act of Adjournal in such form as he considers appropriate.

Jury Lists

3.—(1) The Clerk of Justiciary may require any sheriff principal, on the issue of a requisition notice by him, to return to him in accordance with the provisions of this paragraph a list of persons qualified and liable to serve as jurors for the purposes of the circuits and sittings mentioned in paragraph 2.

(2) Unless the requisition notice otherwise directs, those lists shall, in respect of each place specified in column 1 of Schedule 2 to this Act of Adjournal, consist of such number of persons from the sheriff court districts specified opposite that place in column 2 of that Schedule as is specified opposite that district in column 3 of that Schedule.
