LAND DRAINAGE

The Severn-Trent Water Authority (Reconstitution of the Newark Area Internal Drainage Board) Order 1986

Made - - - - - 3rd September 1986

Coming into Operation 3rd November 1986

Whereas the Severn-Trent Water Authority prepared and submitted to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a Scheme (hereinafter called "the Scheme") under section 11(1) of the Land Drainage Act 1976(a) in relation to the Newark Area Internal Drainage Board;

And whereas the Minister has decided to confirm the Scheme, a copy of which is annexed hereto;

Now, therefore, the Minister, in exercise of the powers conferred upon him by sections 11(4) and 109(6) of the Land Drainage Act 1976, and of all other powers enabling him in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Severn-Trent Water Authority (Reconstitution of the Newark Area Internal Drainage Board) Order 1986 and shall, unless subject to special parliamentary procedure, come into operation on the date of its confirmation by the Minister.

2. The Scheme is hereby confirmed.

3. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Severn-Trent Water Authority and shall be part of the administrative expenses of that Authority.

LAND DRAINAGE ACT 1976
SEVERN-TRENT WATER AUTHORITY
NEWARK AREA INTERNAL DRAINAGE BOARD

The Severn-Trent Water Authority (hereinafter called "the Water Authority") in pursuance of section 11(1) and (5) of the Land Drainage Act 1976, have prepared the following Scheme making provision for the reconstitution of the Newark Area Internal Drainage Board and for matters supplemental thereto or consequential thereon;

And the Water Authority submit the Scheme to the Minister of Agriculture, Fisheries and Food for confirmation under section 11(4) of the said Act of 1976.

SCHEME

1. In this Scheme, unless the context otherwise requires:—

- (a) "the Minister" means the Minister of Agriculture, Fisheries and Food;
- (b) "the appointed day" means a day to be appointed by the Minister for the coming into operation of this Scheme;
- (c) "the Order" means the River Trent Catchment Board (Newark Area Internal Drainage District) Order 1949(a) as altered by the Scheme confirmed by the Anglian and the Severn-Trent Water Authorities (Upper Witham and Newark Area Internal Drainage Districts) Order 1974(b), further altered by the Scheme confirmed by the Severn-Trent and the Anglian Water Authorities (Newark Area and Upper Witham Internal Drainage Districts) Order 1974(c) and further altered by the Scheme confirmed by the Severn-Trent Water Authority (Alteration of Boundaries of the Newark Area Internal Drainage District) Order 1980(d);
- (d) "the Internal Drainage Board" means the Newark Area Internal Drainage Board constituted by the Scheme confirmed by the Order.

2. On the appointed day:

- (i) the Internal Drainage Board shall be reconstituted and shall consist of twenty-one members who, with the exception of the first members, shall be elected in accordance with the provisions of section 7 of, and Schedule 2 to, the Land Drainage Act 1976;
- (ii) the said first members shall be appointed by the Minister and shall hold office until the expiration of one year from the 1 November next following the day on which they are appointed.

3. All such rights, powers, duties, obligations, liabilities and property (including deeds, maps, books, papers and other documents) as were immediately before the appointed day vested in or to be discharged by the Internal Drainage Board as constituted by the Scheme confirmed by the Order, shall on that date become the rights, powers, duties, obligations, liabilities and property of the Internal Drainage Board as reconstituted by this Scheme.
