**The Insolvency Act 1985 (Commencement No. 5) Order 1986**

*Made - - - - 10th November 1986*

The Secretary of State, in the exercise of his powers under section 236(2) of the Insolvency Act 1985<sup>(a)</sup>, hereby makes the following Order:—

1. This Order may be cited as the Insolvency Act 1985 (Commencement No. 5) Order 1986.

2. All the provisions:—

- (a) of Parts I, II and IV of the Insolvency Act 1985; and
- (b) of Schedules 1 to 3, Schedule 4 other than those provisions relating to individual insolvency, Schedules 5 and 6 and Schedules 8 to 10 to that Act other than those provisions relating to individual insolvency,

not yet in force, other than those specified in Article 4 below, shall come into force on 29th December 1986.

3. The provisions of Part III of the Insolvency Act 1985, and the provisions of Schedule 4, in so far as they relate to individual insolvency, Schedule 7 and Schedules 8 to 10 to that Act in so far as they relate to individual insolvency shall come into force on 29th December 1986.

4. The provisions of the Insolvency Act 1985 referred to in Article 2 above are:—

- (a) paragraph 45 of Schedule 6; and
- (b) Schedule 10 in so far as it provides for the repeal of section 467(3) to (5) of the Companies Act 1985<sup>(b)</sup>.
