## FUGITIVE CRIMINAL

**The Extradition (Hijacking) (Amendment) Order 1986**

*Made* - - - - - 25th November 1986  
*Laid before Parliament* 3rd December 1986  
*Coming into Operation* 1st January 1987

At the Court at Buckingham Palace, the 25th day of November 1986

Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred upon Her by sections 2, 17 and 21 of the Extradition Act 1870(a) and sections 9(2) and 39(1) of the Aviation Security Act 1982(b), or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1. This Order may be cited as the Extradition (Hijacking) (Amendment) Order 1986 and shall come into operation on 1st January 1987.

2. The Extradition (Hijacking) Order 1971(c) shall be amended by adding to Schedule 2 (which names the foreign States with which the United Kingdom has extradition treaties in force and which are parties to the Convention for the Suppression of Unlawful Seizure of Aircraft signed at The Hague on 16th December 1970(d)) the following entry:—

3. The Extradition (Hijacking) Order 1971 shall be amended by deleting from Part I of Schedule 3 (which names the foreign States with which the United Kingdom has no extradition treaties in force and which are parties to the Convention for the Suppression of Unlawful Seizure of Aircraft signed at The Hague on 16th December 1970) the entry for Spain.

#### EXPLANATORY NOTE

*(This Note is not part of the Order.)*

The entry into force on 1st July 1986 of the Extradition Treaty between the United Kingdom and Spain, concluded on 22nd July 1985, has necessitated the deletion of the entry for Spain from Part I of Schedule 3 to the Extradition (Hijacking) Order 1971 (which names the foreign States with which the United Kingdom has no extradition treaties in force and which are parties to the Convention for the Suppression of Unlawful Seizure of Aircraft signed at The Hague on 16th December 1970) and the insertion of an entry for Spain in Schedule 2 (which names the foreign States with which the United Kingdom has extradition treaties in force and which are parties to the Convention).
