HOUSING, SCOTLAND

**The Right to Purchase (Prescribed Persons) (Scotland) Order
1986**

Made - - - - - *4th December 1986*

Laid before Parliament *16th December 1986*

Coming into Operation *7th January 1987*

The Secretary of State, in exercise of the powers conferred on him by section 1(10)(u) of the Tenants' Rights, Etc. (Scotland) Act 1980(a) and of all other powers enabling him in that behalf, hereby makes the following order:-

Citation and commencement

1. This order shall be cited as the Right to Purchase (Prescribed Persons) (Scotland) Order 1986 and shall come into operation on 7th January 1987.

Prescribed persons

2. The persons listed in the Schedule to this order and any predecessor of any of those persons are hereby prescribed under section 1(10)(u) of the Tenants' Rights, Etc. (Scotland) Act 1980.

SCHEDULE

A Minister of the Crown, other than a Minister specified in paragraph *(k)*, *(m)*, *(n)*, *(o)*, *(r)* or *(t)* of section 1(10) of the Tenants' Rights, Etc. (Scotland) Act 1980 in relation to a dwelling-house used for the purpose set out in that paragraph.

EXPLANATORY NOTE

(This Note is not part of the Order.)

Under the Tenants' Rights Etc. (Scotland) Act 1980 qualification for the right to purchase and entitlement to discount depend on occupation as a tenant of a dwellinghouse or of a succession of dwellinghouses provided by the public sector landlords mentioned in section 1(10) of the said Act. This order prescribes certain other persons for the above purposes, including Ministers of the Crown not already mentioned for the specific purposes set out in paragraphs *(k)*, *(m)*, *(n)*, *(o)*, *(r)* and *(t)* of the said section 1(10).
