# **COUNTY COURTS**

# The County Court Fees (Amendment) Order 1986

Made - - - 25th March 1986

Laid before Parliament 7th April 1986

Coming into Force 28th April 1986

The Lord Chancellor, in exercise of the powers conferred on him by section 128 of the County Courts Act 1984(a), with the concurrence of the Treasury, hereby makes the following Order:—

- 1.—(1) This Order may be cited as the County Court Fees (Amendment) Order 1986 and shall come into force on 28th April 1986.
- (2) The County Court Fees Order 1982(b) shall be amended in accordance with the following provisions of this Order and in those provisions a fee or column referred to by number means the fee or column so numbered in Schedule 1 to the said Order of 1982.
  - 2. In Fee 1(i) the following shall be substituted for columns 1 and 2 —

It introduces a new fee for registering tribunal and other awards for the purpose of enforcing such awards in a county court.
