# The Dumfries and Galloway Regional Council (River Annan) Amendment Water Order 1986

Made - - - -

Coming into Operation 11th April 1986

The Secretary of State, in exercise of the powers conferred on him by sections 17(2) and 107(1)(b) of the Water (Scotland) Act 1980(a) and of all other powers enabling him in that behalf, on the application of the Dumfries and Galloway Regional Council, hereby makes the following order:-

### Citation and commencement

- 1.—(1) This order may be cited as the Dumfries and Galloway Regional Council (River Annan) Amendment Water Order 1986 and shall come into operation on 11 April 1986.
- (2) This order and the County of Dumfries (River Annan) Water Order, 1955(b) (hereinafter referred to as "the principal order") may be cited together as the Dumfries and Galloway Regional Council (River Annan) Water Orders 1955 and 1986.

## Amendment of the principal order

- 2.—(1) In article 2 of the principal order, for the definition of "deposited plans" there shall be substituted -
  - ""deposited plans" means the plans each prepared in duplicate, sealed with the seal of the Secretary of State for Scotland and marked respectively "The County of Dumfries (River Annan) Water Order, 1955" and "The Dumfries and Galloway Regional Council (River Annan) Amendment Water Order 1986 Plan of Works", one copy of each of which is deposited in the office of the Scottish Development Department, New St Andrew's House, Edinburgh, and the other in the office of the Director of Administration and Law of the Council at Dumfries."
- (2) In the First Schedule to the principal order for Work No. 2 there shall be substituted the following paragraph:-
  - "Work No. 2. A weir across the River Annan incorporating a fish pass situated at a point to the north east of Annan Cemetery and 440 metres or thereby downstream of the Diamond Jubilee Bridge (Suspension)."

- (3) In the First Schedule to the principal order there shall be added the following paragraph:-
  - "Work No. 3. Part demolition of the existing weir and fish pass situated at a point to the north east of Annan Cemetery and 400 metres or thereby downstream of the Diamond Jubilee Bridge (Suspension)."

#### Miscellaneous

3. The Dumfries and Galloway Regional Council shall at all times after the expiration of six months from the date on which this order comes into operation keep in the office of the Director of Administration and Law of the Council a copy thereof and one copy of each of the deposited plans.
