The Milk (Special Designations) (Scotland) Amendment **Order 1986**

Made	30th April 1986
Laid before Parliament	9th May 1986
Coming into Operation	1st June 1986

The Secretary of State, in exercise of the powers conferred on him by sections 3 and 6 of the Milk and Dairies (Amendment) Act 1922(a), and by sections 10 and 11 of the Milk (Special Designations) Act 1949(b), and now vested in him (c), and of all other powers enabling him in that behalf, hereby makes the following order:-

Citation and commencement

1. This order may be cited as the Milk (Special Designations) (Scotland) Amendment Order 1986 and shall come into operation on 1st June 1986.

Amendment of the Milk (Special Designations) (Scotland) Order 1980

- 2.—(1) The Milk (Special Designations) (Scotland) Order 1980(d) shall be amended in accordance with the following provisions of this article.
- (2) In article 18 (milk from England, Wales and Northern Ireland), for paragraph (2) there shall be substituted the following paragraph:-
 - "(2) Where milk is brought into Scotland from Northern Ireland -
 - (a) a Northern Irish licence (that is to say a licence granted under legislation having effect for the time being in Northern Ireland) authorising the sale of that milk under a designation corresponding to a special designation prescribed by this order shall have effect as if it had been granted under this order, and
 - (b) so far as any conditions prescribed in this order for a licence authorising the use of that special designation would relate to anything to be done before that milk enters Scotland, they shall be deemed to be satisfied if the corresponding conditions attaching to that Northern Irish licence are complied with.".

- (3) In Schedule 3 (conditions of licences to use special designations) -
- (a) in Part I -
 - (i) for paragraph 6 there shall be substituted the following paragraph:-
 - "6. Immediately after the milk is cooled, the holder of the licence shall, on the premises where the milk was pasteurised, put it into retail containers or unventilated bulk containers as required, each of which shall be marked or labelled in accordance with the Milk Labelling (Scotland) Regulations 1983(a).";
 - (ii) for paragraph 12 there shall be substituted the following paragraph:

 "12. Every retail container shall be marked or labelled in accordance with the Milk Labelling (Scotland) Regulations 1983.";
- (b) In Part II, for paragraph 2(2) there shall be substituted the following paragraph:-
 - "(2) Every such bottle shall be marked or labelled in accordance with the Milk Labelling (Scotland) Regulations 1983.";
- (c) In Part III, for paragraph 6(3) there shall be substituted the following paragraph:-
 - "(3) Every retail container shall be marked or labelled in accordance with the Milk Labelling (Scotland) Regulations 1983.".
- (4) In Schedule 5 (testing of samples of heat treated milk) -
- (a) (i) in Part II, paragraph 4(i), and
 - (ii) in Part III, paragraph 3(c),
- the words "either B.S.625:1959 or" shall be deleted;
 - (b) in Part II, paragraph 5 for sub-paragraphs (3) and (4) there shall be substituted the following sub-paragraph:-
 - "(3) New glassware shall be cleaned and free from contamination from substances which may interfere with the test.".
- (5) For Schedule 8 (permitted boiler feed water treatment compounds) there shall be substituted the following Schedule:-

3. The Milk (Special Designations) (Scotland) Amendment Order 1983(a) is revoked.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order amends the Milk (Special Designations) (Scotland) Order 1980. The principal amendment is the removal of the restrictions on the importation into Scotland of pasteurised milk produced in Northern Ireland. Such milk is now subject to controls similar to those which apply to milk originating in England and Wales (article 2(2)).

This order also removes a duplication of provision in relation to the labelling of heat treated milk (article 2(3) and article 3) and makes certain other minor amendments concerning the apparatus used in the testing of heat treated milk and the nomenclature of certain permitted boiler feed water treatment compounds (article 2(4) and (5)).
